**ORDER**

WHEREAS, Post Graduate Training College for Physical Education, Banipur, Dist.- North 24 Parganas, West Bengal- 743233 (APE00098) was granted recognition for conducting B.P.Ed. course with an intake of 120 vide ERC order No.1131 dated 12.04.2002, followed by revised order with an intake of 100 vide No.32545 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275<sup>th</sup> (Part-2) meeting held on 27<sup>th</sup> July, 2019 considered that 1<sup>st</sup> show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 17.06.2019 and the institution is still deficient on the following grounds:-

- (i) Building plan is not legible.
- (ii) Principal is not appointed.
- (iii) Submitted faculty list is not in NCTE prescribed proforma.
- (iv) Faculty comprises 09 instead of 1+16 as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Post Graduate Training College for Physical Education, Banipur, Dist.- North 24 Parganas, West Bengal- 743233 (APE00098) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.


