### **ORDER**

WHEREAS, State Institute of Physical Education for Women, Hastings House, 20B, Judges Court Road, Alipore, Kolkata, West Bengal-700027 (APE00394) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC's Order No. 6799 dated 05.03.2007, followed by revised recognition order vide No. 32321 dated 28.05.2015 with an intake of 100 students with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 267<sup>th</sup> Meeting held on 10<sup>th</sup> 11<sup>th</sup> February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.
- 3. **AND WHEREAS,** the institution has submitted reply dated 12.06.2019 in response to SCN, which was considered by ERC in its 274<sup>th</sup> Meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 02.09.2019 to the institution on the following grounds:-
  - (i) Building completion certificate is not signed by Govt. Engineer.
- 4. AND WHEREAS, the institution has submitted reply dated 16.09.2019 received in this office on 20.09.2019. The ERC in its 279<sup>th</sup> Meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-
  - (i) Building Completion Certificate (BCC) duly signed by the competent authority in the prescribed proforma is not submitted.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

5. NOW THEREFORE, recognition granted to the institution viz. State Institute of Physical Education for Women, Hastings House, 20B, Judges Court Road, Alipore, Kolkata, West Bengal-700027 (APE00394) for B.P.Ed. course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
