WHEREAS, Govt. College of Physical Education for Women, P.O.- Dinhata, Dist.- Cooch Behar, West Bengal-736135 (APE00650) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC Order No. 67986 dated 04/07/2007, followed by revised order vide No.32364 dated 29/05/2015 with an intake of 100 from the academic session 2015-2016 as per NCTE, Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 265^{th} meeting held on $8^{th} 9^{th}$ January, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18/01/2019 to the institution on the following grounds:-
 - (i) Show Cause Notice u/s 17(1) was issued on 08/10/2018.
 - (ii) Reply dated 30/10/2018 received from the institution without relevant documents. Point mentioned in the SCN is still deficient.
 - (iii) The Committee allowed 21 days time giving last opportunity for compliance of SCN
- 3. AND WHEREAS, the ERC in its 280th Meeting held on 29th February & 1st March, 2020. Considered the matter and no reply has been received from the institution in response to Show Cause Notice dated 18/01/2019 and decided as under:-
 - (i) No reply has been received against the final show cause notice issued on 18.01.2019.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. Govt. College of Physical Education for Women, P.O.- Dinhata, Dist.- Coach Behar, West Bengal-736135 (Code No. APE00650) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
