ORDER

WHEREAS, Govt. Physical Education College for Women, Chawkabazar, PO.-Hooghly, Dist.- Hooghly, West Bengal-712103 (Code No.APE00651) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC Order No.7350 dated 07.04.2007, followed by revised order vide No.32253 dated 27.05.2015 with an intake of 100 with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 255th meeting held on 30th April to 2nd May, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 15.05.2018 to the institution on the following grounds:
 - (i) Faculty list duly approved by the concerned affiliating body not submitted.
 - (ii) Building completion certificate duly approved by the Govt. Engineer is not submitted.
 - (iii) Blue print of building plan in original duly approved by the Govt. Engineer is not submitted.
 - (iv) Particulars of staff uploaded on institution website is not in the NCTE prescribed proforma.
- 3. AND WHEREAS, reply dated 30.05,2018 from the institution in response to Show Cause Notice was considered by ERC in its 265^{th} meeting held on $08^{th} 09^{th}$ January, 2019 and second Show Cause Notice u/s 17(1) was issued on 16.01.2019 to the institution on the following grounds:
 - Submitted faculty list comprising only 4 teacher. The institution is required to submit faculty list as per NCTE Regulations, 2014.
 - Submitted building plan is in piecemeal. Consolidated building plan approved by Govt. (ii) Engineer is required to be submitted.
 - Website not maintained and updated. (iii)
- AND WHEREAS, the ERC in its 270th Meeting held on 25th 26th March, 2019 considered the matter along with the reply dated 05.02.2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) Show Cause Notice u/s 17(1) were issued on 10.05,2018 & 16.01.2019.
 - (ii) Requisite number of faculty as per NCTE Regulations, 2014 not appointed. Faculty list duly approved by concerned affiliating body not submitted.
 - (iii) The institution has been shifted to its new campus without any approval of ERC, which is in violation of NCTE Act, Rules & Regulations.

In view of the above, the Committee decided as under: The Committee is of the opinion that recognition granted to B.P.Ed. course of the application bearing Code No.APE00651 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

AND WHEERAS, the order of withdrawal was not issued to the institution and the matter was reconsidered by ERC in its 271st meeting held on 24-25 April, 2019 under the Agenda Item No.271.1.26 before confirmation of proceedings of 270th ERC meeting held on 25-26 March, 2019.

- AND WHEREAS, the ERC in its 271st meeting held on 24-25 April, 2019 analyzed the letter vide No.743-Edn(CS)/10M-47/2019 dated 23.04.2019 received from Joint Secretary, Department of Higher Education, Govt. of West Bengal, College Sponsored Branch, Kolkata, in respect of the institution, on the basis of decision taken in 270th meeting uploaded on ERC website and observed that the institution is still deficient on the following grounds:
 - Show Cause Notice u/s 17(1) were issued on 10.05.2018 & 16.01.2019.

(ii) Requisite number of faculty as per NCTE Regulations, 2014 not appointed. Faculty list duly approved by concerned affiliating body not submitted.

(iii) The institution has been shifted to its new campus without any approval of ERC, which is in violation of NCTE Act, Rules & Regulations.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.P.Ed. course of the application bearing Code No.APE00651 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2019-2020.

- NOW THEREFORE, recognition granted to the institution viz. Govt. Physical Education 7. College for Women, Chawkabazar, PO.-Hooghly, Dist.- Hooghly, West Bengal-712103 (Code No. APE00651) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2019-2020.
- FURTHER, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE-Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
