ORDER

WHEREAS, Prabharani Institute of Education, (Physical Education College), Village - Chanak, P.O. - Chanak, P.S. - Nabagram, Dist. - Murshidabad, West Bengal (APE00692) was granted recognition for B.P.Ed. course with an intake of 50 from the academic session 2007-2008 vide ERC dated 04.06.2007, followed by revised recognition order issued on 24.05.2015 with an intake of 100 students with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. AND WHERAS, the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter and as decided, recognition to B.P.Ed. course was withdrawn u/s 17(1) vide order no. 60683 dated 14.06.2019 from the academic session 2020-2021 to the institution.
- 3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-389/E-136850/2019 Appeal/35th Mtg.-2019/25th November, 2019/86020 dated 13/12/2019 remanded back to the ERC with a direction to consider the documents to be submitted to them and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the approved staff list and copies of other documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.
- 4. **AND WHEREAS**, the ERC in its 279^{th} meeting held on $14^{th} 16^{th}$ February, 2020 after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 13.12.2019 as well as reply dated 01.01.2020 submitted by the institution and the following observation was made:

"Restoration of recognition order of B.P.Ed. course to be issued".

5. NOW, THEREFORE, recognition withdrawn vide order dated 14.06.2019 to the institution viz. Prabharani Institute of Education, (Physical Education College), Village - Chanak, P.O. - Chanak, P.S. - Nabagram, Dist. - Murshidabad, West Bengal (Code No. APE00692) for B.P.Ed. course is hereby restored.
