ORDER

WHEREAS, Panskura Banamali College, PO.- Panskura R.S., Dist.-Purba Medinipur, West Bengal-721152 (APE00695) was granted recognition for B.P.Ed. course with an intake of 50 from the academic session 2008-2009 vide ERC's Order No.11943 dated 05.08,2008, followed by revised recognition order vide No.32320 dated 28.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 267th Meeting held on 10th 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.
- 3. AND WHEREAS, the institution has submitted reply dated 13.03.2019 & 18.04.2019 in response to SCN, which was considered by ERC in its 274th Meeting held on 15th 16th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 26.08.2019 to the institution on the following ground:-
 - (i) Total built up area not mentioned in the building completion certificate and building plan.
- 4. AND WHEREAS, the ERC in its 278th Meeting held on 16th 18th January, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-
 - (i) Building plan (BP) duly signed by the competent authority has not been submitted.
 - (ii) Total land area and built up area is not mentioned in the Building Completion Certificate (BCC) submitted by the institution.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.
