ORDER

WHEREAS, Department of Physical Education, Vinaya Bhawan, Visva-Bharati, Santiniketan, West Bengal- 731235 (APE00697) was granted recognition for conducting **B.P.Ed. course** with an intake of 50 vide ERC order No.7911 dated 03.05.2007, followed by revised order with an intake of **100** vide No.32515 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 275th (Part-1) meeting held on 26th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following ground:-

- (i) Faculty list comprises 1+9 instead of 1+16 as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Department of Physical Education, Vinaya Bhawan, Visva-Bharati, Santiniketan, West Bengal- 731235 (APE00697) for **B.P.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
