- 2. **AND WHEREAS**, the ERC in its 275th (Part-1) meeting held on 26th July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2109, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following ground:-
 - (i) Faculty list comprises 1+9 instead of 1+16 as per NCTE Regulations, 2014 for running 100 intake of B.P.Ed. course.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Department of Physical Education, Vinaya Bhawan, Visva-Bharati, Santiniketan, West Bengal-731235 (APE00697) for B.P.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
