**ORDER**

WHEREAS, Department of Physical Education, Vinaya Bhawan, Visva-Bharati, Santiniketan, West Bengal-731235 (APE00697) was granted recognition for B.P.Ed. course with an intake of 50 vide ERC dated 03.05.2007, followed by revised recognition order issued on 28.05.2015 with an intake of 100 students with two sections of 50 each from the academic session 2015-2016 as per NCTE Regulation, 2014.


2. AND WHEREAS, the ERC in its 275<sup>th</sup> meeting held on 26<sup>th</sup> July, 2019 considered the matter and as decided, recognition to B.P.Ed. course was withdrawn u/s 17(1) vide order no. 61472 dated 02.09.2019 from the academic session 2020-2021 to the institution.

3. AND WHEREAS, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-400/E-138101/2019 Appeal/36<sup>th</sup> Mtg.-2019/26<sup>th</sup> November, 2019/86056 dated 13/12/2019 remanded back the case to ERC for revisiting the matter and making appropriate amendments keeping in view that duration of the B.P.Ed. course is two years and basic unit is for 100 students. Appellant institution is required to submit to ERC an exclusive list of faculty for B.P.Ed. course within 15 days of the issue of appeal order.

4. AND WHEREAS, the ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 after considering the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 13.12.2019 as well as representation dated 16.12.2019 submitted by the institution and the following observation was made:

“Restoration of recognition order of B.P.Ed. course to be issued”.

5. NOW, THEREFORE, recognition withdrawn vide order dated 02.09.2019 to the institution viz. Department of Physical Education, Vinaya Bhawan, Visva-Bharati, Santiniketan, West Bengal-731235 (Code No. APE00697) for B.P.Ed. course is hereby restored.


