WHEREAS, in terms of Section 15(3)(a) of the NCTE Act, 1993, A M Teachers Training Institute, Plot No.17, 19, 20, 23, 121, 201, 204, Street No. – Sajurmore, Village - Sajurmore, P.O. - Dafahat, Tehsil/Taluka – Suti, Town/City - Suti, Dist. - Murshidabad, West Bengal - 742224 was granted permission vide ERC order no. ER-207.6.15/ERCAPP3626/D.El.Ed._Addl.Intake /2016/44279 dated 03.03.2016 for conduct of D.El.Ed. course of two years duration with an additional intakes of 100 (two basic units) (existing 50 intake + additional 100 intake), thus making the total intakes of 150 (one hundred fifty) from the academic session 2016-2017.

- 2. AND WHEREAS, the Secretary, A M Teachers Training Institute, Plot No.17, 19, 20, 23, 121, 201, 204, Street No. Sajurmore, Village Sajurmore, P.O. Dafahat, Tehsil/Taluka Suti, Town/City Suti, Dist. Murshidabad, West Bengal 742224 vide its letter dated 17.11.2016 has requested for surrender of additional one unit i.e. additional 50 intake in addition to 100 intake granted to D.El.Ed. programme.
- 3. AND WHEREAS, In view of the above the matter was placed before the ERC in its 225^{th} meeting held on 16^{th} 18^{th} November 2016.
- 4. AND WHEREAS, the Eastern Regional Committee in its 225th meeting held on 16th 18th November 2016 accepted the request of the institution for withdrawn of one unit of 50 intake from the additional intake of 100 (two basic units) granted vide Order No. 44279 dated 03.03.2016 from the session 2016-2017. A fresh revised order be issued to the institution for conducting D.El.Ed. programme of two years duration with an additional intake of 50 (one basic unit), thus making the total intake of 100 (existing 50 intake + Addl. 50 intake) from the academic session 2017-18.
- 5. NOW THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act. 1993, the Eastern Regional Committee, NCTE hereby permits to A M Teachers Training Institute, Plot No.17, 19, 20, 23, 121, 201, 204, Street No. Sajurmore, Village Sajurmore, P.O. Dafahat, Tehsil/Taluka Suti, Town/City Suti, Dist. Murshidabad, West Bengal 742224 for conducting D.El.Ed. Course of two years duration with a reduced intake of 50 (one basic unit) from the approved intakes of 150 thus making the total intake of 100 (existing 50 intake + Addl. 50 intake) from the academic session 2017-2018 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
 - I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from /time to time.

- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- III. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:
 - a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last quarter;
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 10. The institution shall make available list of students admitted on its official website.



11. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
