Order

In terms of Section 14(1) of the NCTE Act, 1993 Panskura Primary Teacher's Training Institute, Vill- Kanakpur, PO- Naranda, Dist-Purba Medinipur, West Bengal- 721139 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting Primary Teacher's Training course of two years duration from the academic session 2004-2005 with an annual intake of 50 (fifty) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team and the reply dated 07/12/2005 of the institution in response to show cause notice, and other related documents, the Committee has noted the following:
 - i. The institution has acquired the land for setting up the teacher education institution and constructed the building.
 - ii. The institution is functioning from its own building.
 - The institution has selected the Principal and 09 (nine) faculty members for the said course and the list of faculty members has not been duly approved by the competent authority of affiliating body i.e. Secretary, West Bengal Board of Primary Education.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Panskura Primary Teacher's Training Institute, Vill- Kanakpur, PO- Naranda, Dist-Purba Medinipur, West Bengal-721139 for PTT Course of two years duration from the academic session 2006-2007 with an annual intake of 50 (Fifty) students subject to compliance of the following conditions before the commencement of the course:
 - a) The institution will ensure that Principal and at least 05 (five) faculty members duly qualified as per NCTE norms are in position for an intake of 50 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of the commencement of the course.
 - b) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the affiliating body within one month of the commencement of the course.
 - c) The institution shall pay salary to the teaching staff as prescribed by State Govt.
 - d) The institution will ensure that salary to the teaching staff is paid through Account payee cheque.
 - e) The institution shall within one month of the receipt of recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (five years) in a Nationalised Bank to be operated along with an official of the Regional Committee.
 - f) The institution shall create a Reserve Fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalised Bank.
 - g) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6.If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
