ORDER

Change of Premises of the institution

Chatta Primary Teachers' Training Institute, Po-Chatta Kalikapur, Via-Batanagar, Ps-Maheshtala, Dist-South 24 Parganas, West Begnal-700140 (APE00771), granted recognition for conducting D.El.Ed. course with an intake of 50 vide ERC order No. ERC/7-87.6(I).28/2008/11947 dated 05.08.2008 as per decision taken in the 87th ERC meeting held on 23rd – 25th July, 2008.

The aforesaid institution had submitted application dated 20.05.2015 for shifting of premises along with requisite documents.


The ERC in its 191st meeting decided that VT to be constituted. Accordingly, the inspection of the institution at new premises was conducted on 29.07.2015 and VT report received at ERC, NCTE on 13/08/2015.

The ERC in its 193rd meeting held on 18th – 19th Aug 2015, after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. VTR, the Committee discussed the matter in detail and decided as under:

➤ "Shifting is allowed with a direction to submit FDR of Rs.4.00 lakh immediately. The institution is advised to furnish the computer centre".

In view of the above, the institution is hereby permitted shifting of premises of the institution from "Chatta Primary Teachers' Training Institute, Po-Chatta Kalikapur, Via-Batanagar, Ps-Maheshtala, Dist-South 24 Parganas, West Begnal-700140" to "Chatta Primary Teachers Training Institute, Khana Jn. Road, Po-Khana Jn., Dist-Burdwan, West Begnal-713141".


