WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, **Sri Ramkrishna College of education, Plot No.-1113, Vill.-Bajkul, P.O.-Kismat Bajkul, Vill.-Bajkul, Tehsil/Taluka-Bajkul, Town/City-Bhupatinagar, Dist.-Midnapore, West Bengal-721655** has submitted an application (Code No.ERCAPP1619) to the Eastern Regional Committee of NCTE for grant of recognition for conducting **D.El.Ed. - (v) The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
