**ORDER**

**Change of Premises of the Institution**

Edugate Teachers Training Institute, Plot No.- 1/33, 1/34, 1/35, Vill – Maliyara, PO- Midnapore, Tehsil/Taluka – Maliyara, Town/City – Midnapore, Dist – Paschim Midnapore, West Bengal - 721101 (ERCAPP689) was granted recognition for conducting D.El.Ed. course with an intake of 50 vide ERC order No. ERC/7-141.6.10/NCTE/D.El.Ed./2012/13883 dated 31.08.2012 as per decision taken in the 141<sup>st</sup> ERC meeting held on 21<sup>st</sup> – 22<sup>nd</sup> August 2012.

The aforesaid institution had submitted application dated 26.06.2015 for shifting of premises along with requisite documents.

The ERC in its 191<sup>st</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> July, 2015 decided that VT be constituted. Accordingly, the inspection of the institution at new premises was conducted on 15.08.2015 and VT report received at ERC, NCTE on 17.08.2015.

The ERC in its 198<sup>th</sup> meeting held on 20<sup>th</sup> – 21<sup>st</sup> November 2015, after considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs., and VT report, the Committee discussed the matter in detail and decided as under:

➤ Shifting permitted.

In view of the above, the institution is hereby permitted shifting of premises of the institution from "Edugate Teachers Training Institute, Plot No.- 1/33, 1/34, 1/35, Vill – Maliyara, PO- Midnapore, Tehsil/Taluka – Maliyara, Town/City – Midnapore, Dist – Paschim Midnapore, West Bengal - 721101" to "Edugate Teachers Training Institute, Mauza-Salika J.L., No- 135, kh. No. 168, Plot Nos.- 338, 339, 340, 341, 344, 345, under PS/Taluka – Midnapore, Manidha Gram Panchayet, Dist – Paschim Medinipur, West Bengal".
