WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Swami Vivekananda College of Education, Plot No. – 597, 587/620, 607, Vill. – Baje Bindole, Po. – Bindole, Tehsil/Taluka – 4 No. Bindole Gram Panchayat, Town/City – Raiganj, Dist. – Uttar Dinajpur, West Bengal – 733156 has submitted an application **(Code No. ERCAPP711)** to the Eastern Regional Committee of NCTE for grant of recognition for conducting D.El.Ed Course with an annual intake of 50 (fifty) by online on (mm/dd/yyyy) 9/29/2010 and hard copy of application submitted on (mm/dd/yyyy) 10/4/2010.

  - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
