ORDER

WHEREAS; Education College, Vill.- Basantapur, PO.- Basantapur, Dist- Murshidabad, West Bengal - 742406 (APE01093) was granted recognition for M.Ed. course with an intake of 25 from the academic session 2009-2010 vide ERC's Order No. 2106 dated 20.11.2009, followed by revised recognition order vide No. 32252 dated 27.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267th Meeting held on 10th - 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. AND WHEREAS, the institution has submitted reply dated 11.03.2019 & 18.03.2019 in response to SCN, which was considered by ERC in its 275th Meeting held on 27th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 11.09.2019 to the institution on the following ground:-

(i) The institution is deficient on the points mentioned in the show cause notice dated 21.02.2019. No supporting document in this regard received.

4. AND WHEREAS, the institution has submitted reply dated 27.09.2019 received in this office on 01.10.2019. The ERC in its 278th Meeting held on 16th - 18th January, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) Qualification of 7 Assistant Professor, 2 Associate Professor is not as per Appendix-5 of NCTE Regulation, 2014.
- (ii) Original FDRs of Rs.5 lakh and Rs.7 lakh has not submitted.

Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.




