- b) The institution shall pay salary to the teaching staff as prescribed by UGC/University through Account Payee Cheque.
- c) The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by concerned affiliating University / UGC. The qualifications of the administrative staff shall be maintained as per norms prescribed by concerned State Govt/affiliating University.
- d) The institution shall obtain affiliation from the examining body before the commencement of the course.
- e) The institution shall maintain and update their website as per NCTE regulations.
- f) Apart from the qualifications prescribed for teachers for M.P.Ed. Course, the candidate shall have to require other qualifications as may be prescribed by NCTE and other regulatory bodies from time to time.
- g) The intakë, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- h) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- i) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc. wherever applicable.
- 5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Charted Accountant.
