Order

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Department of Physical Education, University of Kalyani, Dist – Nadia, West Bengal – 741 235 has submitted an application (Code No: APE00731) to the Eastern Regional Committee of NCTE for grant of permission for starting M.P.Ed. Course of two years duration with an annual intake of 30 (thirty) students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Master of Physical Education (M.P.Ed.) programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants permission to **Department of Physical Education, University of Kalyani, Dist – Nadia, West Bengal – 741 235** for conducting **M.P.Ed. Course of two years** duration with an annual intake of **30 (thirty)** students under clause 7(10) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.



4. Further, the permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc, wherever applicable.
5. The institution shall submit the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the permission under the provisions of Section 17(1) of the NCTE Act.
7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations including inter-alia:
 - i. Copy of the Application Form
 - ii. Land and Building Particulars
 - iii. Staff Profile
 - iv. Permission letter
 - v. Information in terms of having fulfilled the conditions mentioned above, as and when due.
