ORDER

WHEREAS, Loreto College, 7, Middleton Row, Calcutta, West Bengal-700071 (WB-S/E-1/99) was granted recognition for B.Ed. course with an intake of 60 from the academic session 1998-1999 vide ERC's Order No.7142 dated 23.11.98, followed by revised recognition order vide No.32669 dated 31.05.2015 from the academic session 2015-2016 with an intake of 50 (one basic unit) as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267th Meeting held on 10th - 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. AND WHEREAS, the institution has submitted reply dated 22.03.2019 in response to SCN, which was considered by ERC in its 274th Meeting held on 15th - 16th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 02.09.2019 to the institution on the following grounds:-

- (i) Building completion certificate is not submitted.
- (ii) FDRs in joint mode are not submitted.
- (iii) Fire safety certificate issued from competent Govt. Authority is not submitted.

4. AND WHEREAS, the institution has submitted reply dated 16.09.2019 received in this office on 19.09.2019. The ERC in its 278th Meeting held on 16th - 18th January, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-

- (i) As per the reply to SCN dated 02.09.2019 sought some more to complete the building construction, extension of such period is not permissible as per NCTE Act/ Regulation/ Norms & Standard.
- (ii) No separate Building Completion Certificate (BCC) and building plan (BP) to run B.Ed. course submitted.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.




