ORDER

WHEREAS, Govt. College of Education, Burdwan, Kazirhat, P.O. & Dist.-Burdwan, West Bengal -713102 (WB-S/E-4/99) was granted recognition for B.Ed. course with an intake of 65 from the academic session 2000-2001 vide ERC Order No. 1570 dated 19/07/2000, followed by revised order vide No.32652 dated 31/05/2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 275th meeting held on 26th July, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 11/09/2019 to the institution on the following grounds:

- Faculty list is not in accordance with NCTE prescribed proforma and not approved by concerned affiliating body.
- Building plan is not legible.
- Building completion certificate is not submitted.
- Website not maintained and updated.

3. AND WHEREAS, the ERC in its 280th Meeting held on 29th February & 1st March, 2020. considered the matter along with the reply received on 26/08/2019 & 23/09/2019 from the institution in response to Show Cause Notice dated 11/09/2019 and decided as under.

- Faculties for the post of Fine Arts, Music and Physical Education are not appointed as per NCTE Regulation, 2014.
- Total built up area mentioned in the Building Plan (BP) and Building Completion Certificate (BCC) is less for running 1 unit of B.Ed. course as per NCTE Regulation, 2014.
- Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014..

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. NOW THEREFORE, recognition granted to the institution viz. Govt. College of B.Ed. Education, Burdwan, Kazirhat, P.O. & Dist.-Burdwan, West Bengal -713102 (Code No. WB-S/E-4/99) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.




