<u>ORDER</u>

WHEREAS, University B.T. and Evening College, Kesab Road, Kunjabari, Cooch Behar, West Bengal -736101 (WB-S/N-1/2000) was granted recognition for B.Ed. course with an intake of 50 vide ERC's Order No. 2563 dated 05.09.2001, followed by revised recognition order vide No. 32385 dated 29.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 267^{th} Meeting held on $10^{\text{th}} - 11^{\text{th}}$ February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.

3. **AND WHEREAS,** the institution has submitted reply dated 14.03.2019 in response to SCN, which was considered by ERC in its 274^{th} Meeting held on $15^{th} - 16^{th}$ July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 26.08.2019 to the institution on the following grounds:-

- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.

4. **AND WHEREAS**, the institution had failed to submit reply in response to SCN dated 26.08.2019 within stipulated period. The ERC in its 279^{th} Meeting held on $14^{th} - 16^{th}$ February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

(i) No reply has been received against the final show cause notice issued on 26.08.2019.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21. ()
