**ORDER**

WHEREAS, Institute of Science Education, Burdwan University, Rajbati, Dist.- Burdwan, West Bengal- 713104 (WB-S/N-1/99) was granted recognition for conducting B.Ed. course with an intake of 70 from the academic session 2002-2003 vide ERC order dated 17.07.2002, followed by revised order dated 30.05.2015 with an intake of 50 (One basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 272<sup>nd</sup> meeting held on 30<sup>th</sup> - 31<sup>st</sup> May & 1<sup>st</sup> June, 2019 considered the matter along with reply vide letters dated 08.05.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and observed as under:

- (i) Show Cause Notice u/s 17(1) were issued on 21.01.2019 & 18.05.2019.
- (ii) Institution has insufficient faculty members having only 1+5 instead of 1+7 required under NCTE Regulations, 2014.
- (iii) Building plan countersigned by Govt. Engineer/authority not submitted.
- (iv) The submitted building completion certificate is not in accordance with the NCTE Prescribed proforma. Further, there is a short of 30 Sq. Mts. of built up area as stated by University Engineer (In-Charge) of the University.
- (v) The validity of FDR Rs.5 lakh expired on 02.06.2011 in single mode.

**In view of the above, the Committee decided as under:**

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. WB-S/N-1/99 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. **NOW THEREFORE**, recognition granted to the institution viz. Institute of Science Education, Burdwan University, Rajbati, Dist.- Burdwan, West Bengal- 713104 (WB-S/N-1/99) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
