2. AND WHEREAS, the ERC in its 274^{th} meeting held on $15^{th} - 16^{th}$ July, 2019 considered that 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.06.2019 on the following grounds:-

- (i) Faculty list is not in accordance with the NCTE prescribed proforma.
- (ii) Blue print of building plan duly signed by Govt. Engineer not submitted.
- (iii) Building completion certificate is not signed by Govt. Engineer.
- (iv) FDRs in joint mode are not submitted.
- (v) Website not maintained and updated.

No reply received and the stipulated time period has already been over.

In view of the above, the Committee decided as under:

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

3. NOW THEREFORE, recognition granted to the institution viz. Deptt. of Education, Rabindra Bharati University, Emeral Bower Campus, 56-A, B.T.Road, Dist.- Kolkata, West Bengal- 700050 (WB-S/N-2/2000) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
