Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Eastern Regional Committee grants recognition to Govt. Primary Teachers' Training Institute, Derhampore, Murshidabad-742 101 (West Bengal) for Primary Teachers' Training course of one year duration from the academic session 2001-2002 with an annual intake of 50 (fifty) students, subject to fulfilling the following conditions:

- 1. The institution shall appoint/post a duly qualified Principal as per NCTE norms by 30.6.2001.
- 2. The existing 3 teachers appointed after 17.8.95 and not qualified as per NCTE norms shall acquire gualifications by 31.12.2001.
- 3. The institution shall ensure library service with 1500 books and other instructional infrastructure as per the NCTE norms.
- 4. Multipurpose laboratory or educational technology laboratory, psychology laboratory and workexperience laboratory fully equipped as per NCTE norms should be provided by 30.6.2001.
- 5. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
- 6. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
- 7. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
- 8. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

If Govt. Primary Teachers' Training Institute, Berhampore, Murshidabad-742 101 (West Bengal) contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
