ORDER

dated 12.1.2000

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of Govt. Primary Teachers Training Institute, Cooch-Behar (West Bengal) for grant of recognition to the Primary Teachers Training Certificate Course of one year duration, has decided to extend provisional recognition for one year with effect from the academic year 2000-2001 with intake of 60 (sixty) students subject to removal of the following deficiencies:

(i) The Principal's post should be filled.

- (ii) Five teachers besides Principal with the Qualifications prescribed by NCTE should be in position.
- (iii) Laboratory & Library should be enriched as per NCTE norm.
- (iv) Supervised practice teaching should be arranged as per NCTE
- (v) Subscription to the Journals should be augmented as per NCTE norm.

The institution can apply for higher intake if more teachers are qualified as per NCTE norms are appointed in the Institution.

The institution concerned is advised to send a compliance report about removal of above deficiencies to the Eastern Regional Committee by 31.8.2000.
