## ORDER

WHEREAS, Akbarpur Degree College, Akbarpur, Kanpur Dehat-209101, Uttar Pradesh was granted permission for running B.T.C. Course of Two year duration with an annual intake of 50 students vide order No.NRC/NCTE/F-3/UP-1396/2004/8584-8592 dated 24.09.2004.

AND WHEREAS, the inspection of the institution was conducted on 16.09.2006, under section 13 of the NCTE Act, 1993.

AND WHEREAS, the matter was placed before the Committee in its 128th Meeting held on April 09-10, 2008 and the Committee observed that the college is not running the specific teacher education course. The Committee decided that the clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 11.07.2008.

AND WHEREAS, the applicant institution has not submitted any representation, the matter was placed before NRC in its 157<sup>th</sup> Meeting held on 24-27.03.2010, and the Committee decided to close the file. Accordingly, order was issued to the institution on 13.04.2010.

AND WHEREAS, the above said Institution, thereafter, preferred an appeal dated 05.05.2010 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. After perusal of documents, memorandum of appeal, affidavit, VT, Report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal set aside NRC's order dated 13.04.2010 and remanded back the case to NRC vide order dated 19.07.2010 with the direction to allow a period of 3 months for fulfilling the requirement regarding appointment of faculty.

AND WHEREAS, the matter was considered by the committee in its 164<sup>th</sup> Meeting held on August 28-29, 2010 and the committee decided that a letter may be issued to the institution to complete the process of appointment of faculty within 3 months as directed in the appellate authorities order as per the selection procedure stipulated in the NCTE regulations. Accordingly, letter issued to the institution on 30.09.2010.

AND WHEREAS, the reply of the Institution received on 18.10.2010 was considered by NRC in its 172<sup>nd</sup> Meeting held on November 12-13, 2010 and it was decided to issue show-cause notice to the institution. Accordingly, Show-cause notice u/s 17 was issued to the institution on 19.11.2010 on the following grounds:-

- i) The institution has not submitted approval of the Affiliating / Examining Body for the selection/ appointment of the faculty made by them.
- ii) Experience Certificate of the Principal establishing 5 years experience in E.T.T. has not been submitted.
