WITHDRAWAL ORDER

WHEREAS, the institution namely Vallabh Government College, Mandi, District – Mandi, Himachal Pradesh – 175001 has been recognized by NRC for conducting B.Ed. programme of one-year duration with an annual intake of 100 students vide Order No. NRC/NCTE/F-3/HP-116/1838-1846 dated 25.05.2005.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution consented to come under new Regulation vide a notarized affidavit dated **15.12.2014**.

3. AND WHEREAS, the Revised Recognition Order was issued to the institution for conducting **B.Ed.** programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 *vide* order No. **F.NO./NRC/NCTE/HP-116/2015/119185-90** dated **22.07.2015**. The institution was directed to submit the compliance report with all necessary documents but the institution has not submitted reply in compliance of the revised recognition order.

4. AND WHEREAS, the matter was placed before NRC in its 281st Meeting held on 20th - 21st February 2018. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order.

5. AND WHEREAS, as per decision of NRC, a Show Cause Notice was issued to the institution on 26.03.2018.

6. AND WHEREAS, the matter was placed before the NRC in its 418th Meeting held on 23rd & 24th January, 2024 and the committee decided as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines, and Visiting Team Report issued from time to time were placed before the Northern Regional Committee.

The Committee decided that a **Final Show Cause Notice** before withdrawal of recognition of B.Ed. course under Clause 17 of NCTE Act, 1993 be issued to the institution for submission of compliance with a period of 07 (seven) days from the date of issue of Final SCN on the following grounds: -

- (i) The institution is required to submit Certified registered land documents issued by the Registering Authority
- (ii) The institution is required to submit Blueprint of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No.. total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as classrooms etc.
- (iii) The institution is required to submit a Land Use Certificate issued by the Competent Government Authority to use the land for educational purposes.
- (iv) The institution is required to submit a Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (v) The institution is required to submit a certified copy of a site plan with demarcated land area for running different courses.
- (vi) The institution is required to submit a Building safety certificate from the Competent Government Authority.
- (vii) The institution is required to submit a Fire safety certificate issued by the Competent Government Authority.
- (viii) The institution is required to submit a Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (ix) The institution is required to submit a Building Completion Certificate signed by the Competent Government Authority.
- (x) The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs.
- 10/- non-judicial stamp paper by each selected/ appointed faculty in the NCTE prescribed proforma.
 (xi) The institution is required to submit details of salary disbursed to the faculty
- (xi) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xii) The institution is required to submit original valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xiii) The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.

- (xiv) Status of NAAC.
- (xv) The website of the institution is not updated as required under clause 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- (xvi) The institution is required to submit copies of the affiliation orders of last three years issued by the concerned affiliating body for each course being run by the institution / society.
- (xvii) The institution is required to submit a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution / society.

7. Accordingly, Final Show Cause notice was issued to the institution on 06.02.2024.

8. AND WHEREAS, the institution submitted its reply in response to the Final Show Cause Notice vide its letter dated 17.02.2024 received in NRC on 28.02.2024 which was considered by NRC in its 422nd meeting held on 06th & 7th June, 2024 and the NRC has decided as under: -

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, reply to Final SCN, guidelines issued from time to time were placed before the Northern Regional Committee and the NRC observed the following: -

- The institution has not submitted the certified copy of the registered land documents in the name of institution / society.
- The institution has not submitted the blue print of the approved building plan signed by the competent Government Authority. The institution has stated that it shares the old Arts Block of the Vallabh Government College Mandi for running B.Ed. Course and has submitted the building plan of the Arts Block, which is not acceptable as per NCTE Regulations.
- The plot no. / khasra no. not mentioned in the Land use certificate submitted by the institution.
- Site plan submitted is not issued by the competent govt. authority. Demarcated land area for running difference courses not shown in the site plan.
- The institution has not submitted the fire safety certificate

- The institution has not submitted the certificate to the effect that the building is differently abled friendly from the competent Government authority.
- Building completion certificate submitted is not approved by the competent govt. authority. As per the BCC the total land area earmarked for the teacher training programme is 21600 sq.ft which is less than the required as per the NCTE norms for intake of 2 units.
- List of teaching staff submitted is not approved by the affiliating body.
- Requisite number of teaching staff qualified as per NCTE norms not appointed. Further the teachers are appointed on part time basis.
- Only 04 faculties has submitted the Affidavit on Rs.10/- stamp paper.

- Notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management not submitted.
- The institution has not submitted the the details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.

Hence, the Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the date of communication of withdrawal order. Hence, no fresh admission shall be done in next academic session i.e. 2024-25".

9. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraw recognition of Vallabh Government College, Mandi, District – Mandi, Himachal Pradesh – 175001 for conducting B.Ed programme with annual intake of 100 students (02 basic unit) with effect from the date of communication of withdrawal order.

No fresh admission shall be done in next academic session i.e. 2024-2025.

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
