ORDER

WHEREAS, in terms of section 15(1) of the NCTE Act, 1993 Ram Nagina Kisan P.G. College, Vill- Muriyari (Todarpur), Post- Jakhania (Khetabpur), Tehsil- Jakhania, District- Ghazipur-275203, Uttar Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.P.Ed Course of One year duration with an annual intake of 50 (Fifty Only) students on 30.10.2008.

AND WHEREAS, the deficiency letter issued to the institution on 16.02.2009 and the reply of the institution (in response to deficiency letter) was considered by the committee in its 141<sup>st</sup> Meeting held on from March 14<sup>th</sup> to 16<sup>th</sup>, 2009 and committee decided to close the file. Accordingly, closer order was issued to the institution on 13.08.2009.

AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 03.07.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 11.09.2009 and remand back the case for inspection of the institution to ascertain availability of necessary infrastructure, instructional and other facilities in accordance with the norms prescribed by the NCTE to become eligible for recognition by NCTE. Accordingly, appeal was accepted and the case was remanded back to the NRC for inspection of the institution immediately. The inspection of the institution under section 15 was conducted on 23.03.2010.

AND WHEREAS, on scrutiny perusal of the application submitted by the institution, the documents attached therewith, the affidavit, input received from the visiting team in the form of report/ videography and the input received from recommendation of the State Government, the Northern Regional Committee in its 159<sup>th</sup> Meeting held from April 28<sup>th</sup>, May 01<sup>st</sup>, 2010 decided to issue Show Cause Notice on certain deficiencies. Accordingly show cause notice was issued to the institution on 15.05.2010.

AND WHEREAS, the reply of the show cause notice has been carefully considered by NRC in its 162<sup>nd</sup> Meeting held from June 24-27, 2010 and NRC decided to issue letter of intent under clause 7(9) of the regulation 2007. Accordingly, letter was issued to the institution on 05.10.2010.

AND WHEREAS, the reply of the institution dated 29.11.2010 w.r.t. letter dated 05.10.2010 issued under clause 7(9) has been considered by NRC in its 175<sup>th</sup> Meeting held from December 30-31, 2010 and it has been observed that:-

- The institution has not submitted a copy of the letter of the University, carrying its approval for appointment of the Faculty made by the institution

AND WHEREAS, the reply of the institution dated 04.03.2011 and the original file was considered by NRC in its 180 Meeting held from 23<sup>rd</sup> March to 26<sup>th</sup> March, 2011, 31<sup>st</sup> March to 1<sup>st</sup> April and 9<sup>th</sup> April to 11<sup>th</sup> April 2011 and NRC decided that the Formal Recognition order under clause 7(11) of the NCTE Regulation, 2009 be issued.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Ram Nagina Kisan P.G. College, Vill- Muriyari (Todarpur), Post- Jakhania (Khetabpur), Tehsil- Jakhania, District- Ghazipur-275203, Uttar Pradesh for conducting B.P.Ed. one year Course with an annual intake of 50 (Fifty only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
- ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc. wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.


