WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act 1993, the NCTE-NRC granted recognition to Gajadhar Gurukul Nanhakudas Mahavidyalaya, Plot No. 917, Kaptainganj to Ahiraula, Wajidpur, Tahar Wajidipur, Burhanpur, Dist. Azamgarh 276141 (U.P.), for running B.Ed. Course vide Order No. File No. NRC/NCTE/Recognition/B.Ed./2016/43895-3978 dated 03.03.2016 for an annual intake of 50 students.

AND WHEREAS, the matter was considered by the NRC in its 256th (Part-2) meeting held from 22nd to 25th August, 2016 and the committee decided to issue of Show Cause Notice on the following points:-

As per letter no. पत्रांक-प.वि.वि. / सम्ब. /01-(जॉच) 2016/8559 dt. 28.07.2016 received on 07.08.2016 from the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur, U.P., the Committee decided that show cause notice be issued to the institution under section 17 of the NCTE Act, 1993 before withdrawal of recognition of the institution on the ground that the list of faculty duly approved by the affiliating body and submitted by the institution in the office of NRC for getting recognition is fake.

Hence, show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

AND WHEREAS, the institution submitted its reply on 07.10.2016. The matter was considered by the NRC in its 261st meeting held from 14th to 19th December, 2016 and the Committee decided as under:-

- The institution submitted lists of faculty dt. 18.12.2015 & 24.12.2015 claimed to have been approved by the affiliating university on the basis of which it was granted recognition by NCTE to run the B.Ed. course.
- The affiliating university i.e. Veer Bahadur Singh Purvanchal University, Jaunpur made a complaint vide its letter dt. 28.07.2016 received in NRC office on 07.08.2016 against some institutions including the present one that the list of faculty claimed to have been approved by the affiliating university on 18.12.2015 & 24.12.2015 has not been issued by the university and the university approved the list only on 29,04,2015.
- The institution has thus submitted a fake list of faculty for seeking grant of recognition.
- The list of faculty dt. 29.04.2016 submitted by the institution vide its letter received in NRC office on 07.10.2016 in response to SCN dt. 17.09.2016 cannot be accepted now since institution was granted recognition for B.Ed. course by NRC on 03.03.2016 for which institution submitted the fake list of faculty.

NRC decided to withdraw the recognition for B.Ed. course under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal.

NOW THEREFORE, in exercise of the powers vested under Section 17 of the NCTE Act, 2014, the Northern Regional Committee hereby withdraws the recognition granted to the institution i.e , Gajadhar Gurukul Nanhakudas Mahavidyalaya, Plot No. 917, Kaptainganj to Ahiraula, Wajidpur, Tahar Wajidipur, Burhanpur, Dist. Azamgarh 276141 (U.P.), for B.Ed. course on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.

If the institution is not satisfied by the above order, it may prefer an appeal to the Council (NCTE, New Delhi) in terms of Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncteindia.org within 60 days from the issue of this order. The guidelines for filing appeal may be seen on NCTE website.
