WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Adarsh Kanya Mahavidyalaya, Jiyapur, Baruya Jalaki, The-Tanda Ambedker Nagar-224214 Uttar Pradesh for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2003-2004 vide NRC order No.NRC/NCTE/F-3/UP-962/2003/2774 dated 09.07.2003.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the institution has not consented to come under the Regulations, 2014 and the affidavit in this regard was also not submitted by the institution. Hence, revised recognition Order for B.Ed. course one year duration was not issued to the institution.

3. AND WHEREAS, The matter was placed before NRC in its 325th Meeting held on 08th to 09th January, 2021 and the Committee decided as under:

“Consideration of the matter of Revised Recognition Order (RRO)

Regional Director placed before the committee, list of 362 such institutions to whom RRO has not been issued till today due to not submission of required affidavit stating that institution and decision of committee.

The committee discussed the matter in depth and decide to issue show cause section 17 to institution as per list put up before committee for not making compliance to Regulations, 2014.”

4. AND WHEREAS, accordingly, show cause notice u/17 was issued to the institution vide letter no. F.NRC/NCTE/(item No.107/minutes of the 325th (Virtual) meeting/2020/210876-211237 dated 19.01.2021. the institution has not submitted reply of show cause notice.

5. AND WHEREAS, the institution has not submitted reply of show cause notice. The matter was placed before NRC in its 403rd (Online mode) Meeting held on 13th & 14th July, 2023 and the Committee decided that final show cause under section 17 of NCTE Act, 1993 be issued to institutions to submit reply within 07 days from the date of issue of show Cause Notice on the following grounds:-

- The revised recognition order was not issued to the institution.

- As per decision of NRC in its 325th meeting the first show cause notice was issued to the institution on 19.01.2021.
- Reply of the First SCN has not been submitted by the institution.

Hence, the NRC decided that Final Show Cause Notice Under Section 17 of NCTE Act, 1993 be issued to the institution to submit reply within 07 days from the date of issue of show cause notice.

Accordingly, Final Show Cause Notice was issued the institution vide letter No. NRC/NCTE/UP-962/B.Ed./403rd (Online mode) Meeting2023/223106-223107 dated 24.08.2023.

6. **AND WHEREAS**, the institution has submitted reply of final show cause notice vide letter dated 13.09.2023. The matter was placed before NRC in its 418th Meeting held on held on 23rd and 24th January, 2024 and the Committee decided as under:-

The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the NRC after careful consideration made the following **observations**: -

1. The Revised Provisional Recognition under the NCTE Regulations, 2014 was not issued to the institution as the Affidavit was not submitted by the institution.
2. A first show cause notice dated 19.01.2021 to the institution.
3. The institution did not submit any reply to the first show cause notice dated 19.01.2021.
4. Final Show Cause Notice dated 24.08.2023 was issued to the institution.
5. Reply submitted by the institution agasint the Final Show Cause Notice vide letter dated 13.09.2023 clearly establishes the Affidavit dated 15.02.2020 was sent to NRC, NCTE vide its letter dated 17.02.2020. It is also evident that the affidavit was not submitted in 2015 for issuance of RPRO under NCTE Regulations, 2014 for ocnduct of B.Ed. course of 2 years duration.

Hence the **recognition granted to Adarsh Kanya Mahavidyalaya, Jiyapur Sarua, Jalaki, Teh. - Tanda, Ambedkar Nagar, UP for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 with effect from the academic session 2024-2026.** No fresh admissions with effect from the academic session 2024-2026 are permitted from now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn.


NOW THEREFORE, in view of the above decision of NRC, the NRC hereby **withdraw** the recognition granted to the institution namely **Adarsh Kanya Mahavidyalaya, Jiyapur, Baruya Jalaki, The-Tanda Ambedker Nagar-224214 Uttar Pradesh** for B.Ed. course of one year duration with an annual intake of 100 students with effect from the academic session 2024-2026.
