RECOGNITION ORDER

WHEREAS in terms of Section 14(1)/15(1) of the NCTE Act, 1993, the institution had submitted application online on 29.05.2015 to the Northern Regional Committee of NCTE for grant of recognition/permission for Teacher Education Course.

12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw recognition under provisions of Section 17(1) of the NCTE Act, 1993.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
