WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to **Sant Ram Krishna Kanya Mahavidyalaya, Shivpuri, Balkeshwar Road, District – Agra, State – Uttar Pradesh** vide Order No. NRC/NCTE/F-3/UP-1243/5677-5685 dated 10.08.2004 with an annual intake of 100 seats in B.Ed. course.

2. AND WHEREAS, the permission was granted to the institution for additional intake of 100 seats in B.Ed. Add. Intake course vide order No. NRC/NCTE/F-73/UP-2327/2007/32863-32869 dated 27.11.2007 (Existing 100 + Additional 100 = 200 seats).

3. AND WHEREAS, the permission was granted to the institution for additional intake of 100 seats in B.Ed. Add. Intake course vide order No. NRC/NCTE/F-7/UP-2708/2008/58457-63 dated 23.08.2008 (Existing 200 + Additional 100 = 300 seats).

4. AND WHEREAS, the Revised Recognition order was issued to the institution for two years B.Ed. course No. NRC/NCTE/UP-2327/2015/112957-63 dated 06.06.2015 with an annual intake of 200 seats (4 Units of 50 students each) from the academic session 2015-2016 was issued to the institution with certain conditions.

5. AND WHEREAS, the Corrigendum No. NRC/NCTE/UP-1243, UP-2327 & UP-2708/2015/119467-71 dated 28.07.2015 for B.Ed. course of two years duration with an annual intake of 300 seats (6 Units of 50 students each) and Show Cause Notice dated 28.03.2018 was issued to the institution for non-submission the compliance of conditions mentioned in the revised recognition order.

6. AND WHEREAS, as per the decision of the Northern Regional Committee in its 281<sup>st</sup> Meeting, a Show Cause Notice u/s 17 was issued on 28.03.2018 to the institution on following grounds with a direction to submit the reply to Show Cause Notice within 21 days from the date of issue of SCN.

- “The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- The institution should have already identified/selected the faculty/staff by 29<sup>th</sup> February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30<sup>th</sup>, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc."

7. **AND WHEREAS**, Dr. B. R. A. University, Agra, stated in their letter No. 8092/2019 dated 19.01.2019 that एन0सी0टी0ई0 द्वारा बी0एड0 पाठ्यक्रम संचालन हेतु विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी0एड0 पाठ्यक्रम में छात्रों के पठन पाठन हेतु एक यूनिट (50 छात्र) पर 0803 (विशिष्ट विषय शिक्षक -फाईन आर्ट, संगीत एवं शारीरिक शिक्षा ) 11 तथा दो यूनिट (100 छात्र) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था. किन्तु विनियमन लागू होने क 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर्स-फैकल्टी और नही विशिष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपति जी के दिनांक 16.11.2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षकों का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218/सत्तर-2-2011-16(409)/2010 दिनांक 23.08.2011 के अनुपालन में विश्वविद्यालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या संब/4213/2017 दिनांक 17.11.2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या संब/4361/2017 दिनांक 15.12.2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी0एड0 पाठ्यक्रम से संबंधित विभिन्न बौद्धित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी। परन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आज तक उपलब्ध नही करायी गयी, जो कि संबद्धता शर्तों का उल्लंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबन्धन/प्रशासन उपरोक्त पाठ्यक्रम को संचालित करने में रुचि नही ले रहा है।

8. **AND WHEREAS**, as per decision of the NRC in its 301<sup>st</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> May, 2019, a show cause notice u/s 17 was issued to the institution on 02.07.2019 on the following grounds:-

- "The committee decided to send a notice to all 134 Teacher Education Institutions u/s 17 of NCTE Act, 1993 affiliated to Dr. Bhim Rao Ambedkar Vishwavidyalaya, Agra, Uttar Pradesh in order to seek their comments on the complaint raised by the affiliating university."

Accordingly, Second Show Cause Notice U/S 17 (Complaint) was forwarded letter to the institution on 10.06.2019.

9. AND WHEREAS, the institution has submitted reply in NRC Office on 15.07.2019. The matter was considered by the Northern Regional Committee in its 311<sup>th</sup> Meeting held from 16<sup>th</sup> to 17<sup>th</sup> January, 2020 and the Committee, observed the following:-

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observations were made that: -

- The institution has not submitted approved faculty list in original with the details of their academic qualifications/ experience etc.
- The institution has not submitted the details of salary disbursed to the faculty along with six months Bank statement along with account number of each faculty members.
- The reply of SCN dated 10.06.2019 submitted by the institution is not satisfactory as it does not address the above deficiencies and the institution is being given final opportunity before withdrawal of recognition.
- Further, the website link showing the faculty details is not submitted by the institution.

Hence, second show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.”

10. AND WHEREAS, the matter was placed before NRC in its 312<sup>th</sup> (Emergent) Meeting held from 14<sup>th</sup> February, 2020 and the Committee decided on the following grounds: -

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observation was made that: -

- As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution. The file must be placed before NRC in its 313<sup>th</sup> Meeting.”

11. AND WHEREAS, the institution has submitted reply in NRC Office on 17.02.2020, 19.02.2020 & 20.02.2020. The matter was considered by the NRC in its 315<sup>th</sup> (Virtual) Meeting held from 17<sup>th</sup> to 20<sup>th</sup> August, 2020 and the Committee decided as under:-

“The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the Committee made following observations:-

- Hence, NRC decided to withdraw order be issued to the institution as per decision taken in 312<sup>th</sup> (Emergent) meeting the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.”

12. **AND, WHEREAS**, the matter was considered by the NRC in its 317<sup>th</sup> (Virtual) Meeting held from 22<sup>nd</sup> to 23<sup>rd</sup> September, 2020 and the Committee decided as under:-

“In compliance with the order of Hon’ble High Court of Delhi dated 09.09.2020 in W.P.(C) 6159/2020 and C. M. No. 22082/2020, the matter was considered by the Committee and after carefully examining the facts contained in the file of the petitioner institution NRC observed that the reply of the second and final Show Cause Notice issued to the institution u/s 17 of NCTE Regulations, 2014 on 10.06.2019 on following grounds has not been submitted till today.

- Latest list of the faculty for B.Ed. course duly approved by the concerned affiliating body has not been submitted.
- Bank statement of the payment of salary to the faculty for last six months has not been submitted.

Hence, Committee decided to withdraw the recognition for the B.Ed. course of the institution with effect from the end of the current academic session 2020-2021.

A detailed order of withdrawal of recognition be issued to the institution as well as to the concerned authorities.”

13. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Sant Ram Krishna Kanya Mahavidyalaya, Shivpuri, Balkeshwar Road, District – Agra, State – Uttar Pradesh** granted for B.Ed. course for an intake of 300 Seats (Existing 200 + Additional 100 = 300 Seats vide order dated 10.08.2004, 27.11.2007 & 23.08.2008 & Revised Recognition order dated 06.06.2015 and subsequent Corrigendum dated 28.07.2015 on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.


