WITHDRAWAL ORDER

WHEREAS, the recognition was granted by the Northern Regional Committee to F. S. College of Education, Near Balaji Mandir, Bye Pass Road, Shokohabad, Bamroli Katra, District – Firozabad, State – Uttar Pradesh vide Order No. NRC/NCTE/F-3/UP-1275/5646-5654 dated 10.08.2004 for B.Ed. course of one year duration with an annual intake of 100 seats from the academic session 2004-05. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-1275 & NRCAPP-2661/B.Ed./2015/113076-082 dated 06.06.2015 for B.Ed. course of two years duration with an annual intake of four units of 50 students each was issued to the institution with certain conditions.

2. AND, WHEREAS, the institution has not submitted documents/reply in compliance of the revised recognition order.

3. AND, WHEREAS, the matter was placed the Northern Regional Committee in its 281<sup>st</sup> Meeting held from 20<sup>th</sup> to 21<sup>st</sup> February, 2018. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order.

Accordingly, Show Cause Notice dated 24.03.2018 was issued to the institution.

4. AND, WHEREAS, Dr. B. R. A. University, Agra, stated in their letter No. 8043/2019 dated 19.01.2019 that एन0सी0टी0ई0 द्वारा बी0एड0 पाठ्यक्रम संचालन हेतु विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी0एड0 पाठ्यक्रम में छात्रों के पठन पाठन हेतु एक यूनिट (50 छात्र) पर 0803 (विशिष्ट विषय शिक्षक –फाईन आर्ट, संगीत एवं शारीरिक शिक्षा ) 11 तथा दो यूनिट (100 छात्र) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने क 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर-फैकल्टी और नही विशिष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपति जी के दिनांक 16.11.2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षको का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218/सत्तर-2-2011-16(409)/2010 दिनांक 23.08.2011 के अनुपालन में विश्वविद्यालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या संब/4213/2017 दिनांक 17.11.2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या संब/4361/2017 दिनांक 15.12.2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी0एड0 पाठ्यक्रम से संबंधित विभिन्न वॉछित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी। परन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आजतक उपलब्ध नही करायी गयी, जो कि संबद्धता शर्तों का उलंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबन्धन/प्रशासन उपरोक्त पाठ्यक्रम को संचालित करने में रुचि नही ले रहा है।

5. **AND, WHEREAS,** as per decision of the NRC in its 301<sup>st</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> May, 2019, a show cause notice u/s 17 was issued on the institution on 20.06.2019 seeking their comments on the complaint raised by the affiliating university.


6. **AND, WHEREAS,** the matter was considered by the NRC in its 311<sup>th</sup> Meeting held from 16<sup>th</sup> to 17<sup>th</sup> January, 2020 and the Committee decided as under: -

- As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution.

**Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.**

7. **NOW, THEREFORE,** in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **F. S. College of Education, Near Balaji Mandir, Bye Pass Road, Shokohabad, Bamroli Katra, District – Firozabad, State – Uttar Prades** granted for **B.Ed.** course for an intake 200 seats on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
