WITHDRAWAL ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Shri Radha Rani Degree College, Julahpur, Post Office - Kachaura, District - Mahamaya Nagar, State - Uttar Pradesh vide Order No. NRC/NCTE/F-3/UP-930/2003/3139 dated 22.07.2003 for B.Ed. course of one year duration with an annual intake of 100 seats from the academic session 2003-2004. The revised recognition order for two years B.Ed. course was not issued to this institution due to non-submission the required affidavit in NRC office.

And Whereas, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

And Whereas, the NCTE Hqrs. Vide letter no. 51-4/2014/NCTE/N&S/A 101332 dated 27.12.2014 has issued guidelines and it is specifically stressed in para 1 of explanatory note attached with the guidelines and it is specifically stressed in para 1 of explanatory note attached with the guidelines that "...However, if the institution is not willing to fulfil the norms prescribed in the New regulations as mentioned above, its recognition will automatically become invalid as the old Regulations (NCTE Regulations, 2009) have already been superseded..."

And Whereas, the institution had not submitted an affidavit as its acceptance for adherence to the provisions of the NCTE Regulations, 2014 and therefore, a revised provisional recognition order (RPRO), as per NCTE Regulations, 2014, was not issued to the institution.

2. And Whereas, Dr. B. R. A. University, Agra, stated in their letter No. 8073/2019 dated 19.01.2019 that एन०सी०टी०ई० द्वारा बी०एड० पाठ्यकम संचालन हेतु विनियमन 2014 लागू किया गया है उक्त विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी०एड० पाठ्यकम में छात्रों के पठन पाठन हेतु एक यूनिट (50 छात्र) पर 0803 (विशिष्ट विषय शिक्षक —फाईन आर्ट, संगीत एवं शारीरिक शिक्षा) 11 तथा दो यूनिट (100 छात्र) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने क 04 वर्ष बाद भी आपके महाविद्यालय द्वारा न तो कोर-फैकल्टी और नहीं विशष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा हेतु शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपित जी के दिनांक 16.11.2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षकों का अनुमोदन 05 वर्ष पूर्ण होने पर शासनादेश संख्या 2218/सत्तर—2—2011—16(409)/2010 दिनांक 23.08.2011 के अनुपालन में विश्वदिद्यालय से पुनः अनुमोदन निरस्त कर दिया गया है। इस संबध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या संब/4213/2017 दिनांक 17.11.2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या संब/4361/2017 दिनांक 15.12.2017 के द्वारा भी आपके महाविद्यालय में संचालित

• In compliance with the Hon'ble High Court of Delhi Order dated 29.07.2020, the matter was considered and decided by the NRC that Re-Joinder/Counter Affidavit alongwith the application may be filed to vacate the stay and with due permission of the Hon'ble High Court of Delhi, if permit, withdrawal order may be issued further.

Now Therefore, in view of the above, the recognition granted to the institution vide order no. NRC/NCTE/F-3/UP-930/2003/3139 dated 22.07.2003 for conducting B.Ed. course become invalid as per directions & guidelines issued by the NCTE Hqrs. Vide letter no. 51-4/2014/NCTE/N&S/A101332 dated 27.12.2014 and decision of NRC thereof, file of the institution is closed.

7. Now Therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of Shri Radha Rani Degree College, Julahpur, Post Office - Kachaura, District - Mahamaya Nagar, State - Uttar Pradesh granted for B.Ed. course on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
