ORDER

24 MAR 2023

WHEREAS, recognition was granted to the institution namely Amarpali Institute of Management and Computer Applications, Shiksha Nagar, lamachaur, Haldwani, Distt. Nainital, Uttrakhand-263139 for ETE Course of an annual intake of 50 seats with effect from November 05, 2004 vide NRC order No. F.NRC/NCTE/F-3/UR-10/10186-10195 dated 08.11.2004.

2. AND WHEREAS, the matter of Non-submission of Performance Appraisal Report (PAR) by the institutions for the academic session 2020-21 was considered by NRC in its 380<sup>th</sup> Meeting (Blended Mode, Part-B) held on 08.10.2022 and the Committee observed and decided to issue SCN U/S 17 of the NCTE Act, 1993 for non-submission of PAR for the Academic Session 2020-21.

3. AND WHEREAS, in response of SCN dt. 07.11.2022, the institution has submitted a reply dated 17.11.2022, stating that "Institute wish to inform you that we are not running and have never granted recognition from NCTE for the D.El.Ed. course. Institute is running only B.Ed. programme vide NCTE Order No.NRC/NCTE/F-3/UP-696/2002/9306 dated 19.12.2002 and Revised Order No.NRC/NCTE/UP-696/2015/109050 dated 31.05.2015.

4. AND WHEREAS, the matter was considered NRC in its 391<sup>st</sup> (Virtual Mode) Meeting held on 02<sup>nd</sup> February, 2023 and the Committee decided to withdraw the recognition of D.El.Ed. course on the following ground :-

*"The institution vide letter dated 17.11.2022 informed that the institution is not running D.El.Ed. course and have never granted recognition from NCTE."*

In view of the above, the Committee decided to withdraw the recognition of D.El.Ed. course to the institution under Section 17 of NCTE Act, 1993.

5. NOW THEREFORE, in view of the above decision of NRC, the NRC hereby withdraws the recognition granted to the institution namely Amarpali Institute of Management and Computer Applications, Shiksha Nagar, Lamachaur, Haldwani, Distt. Nainital, Uttrakhand-263139
