CORRIGENDUM

WHEREAS, the recognition was granted to the institution namely, **ACME Institute of Management and Technology, 1, K.M. Ahead from Sikandra, Near Sudhir Dharm Kanta, Mathura Bye Pass Road, Agra, Uttar Pradesh** for annual intake of 50 students for B.P.Ed. Course vide letter No. F.NRC/NCTE/F-3/UP-814/3680-3588 dated 06.07.2004 followed by revised order No.F.No./NRC/NCTE/UP-8142015/11874-79 dated 08.06.2015 for conducting B.P.Ed. programme of two year duration with an annual intake of 50 students each form the academic session 2015-16.

2 AND WHEREAS, the matter was placed before 421st meeting of NRC-NCTE held on 21st to 22nd May, 2024 and decided as under:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules Regulations, SOP, guidelines issued form time to time were placed before the Northern Regional Committee.

- *The NRC considered the representation dated 20.03.2024 & 07.05.2024 submitted by the institution requesting to correct the unit size of B.P.Ed. course form the 50 seats to 100 seats and the Committee decided to correct the unit size of B.P.Ed. course as 100 seats (One unit) as per Appendix-7 of the NCTE Regulations 2014 as amended from time to time.*

Hence, the Committee decided that the unit size of B.P.Ed. course granting recognition to the institution be corrected from 50 seats to 100 seats (One unit) as per Appendix-7 of the NCTE Regulations, 2014 as amended form time to time. Order be issued accordingly.”

3 NOW, THEREFORE, in compliance of the decision of the NRC, the intake of seats for recognition granted to the institution namely, **ACME Institute of Management and Technology, 1, K.M. Ahead from Sikandra, Near Sudhir Dharm Kanta, Mathura Bye Pass Road, Agra, Uttar Pradesh** is rectified from 50 seats to 100 seats (One unit) for B.P.Ed. programme as per Appendix-7 of the NCTE Regulations, 2014 as amended form time to time.

The above order shall come into force immediately after the aforesaid decision of the NRC taken in its 421st meeting held on 21st to 22nd May, 2024. The other contents of the revised order No.F.No./NRC/NCTE/UP-8142015/11874-79 dated 08.06.2015 for conducting B.P.Ed. programme of two year duration shall remain the same subject to fulfilment of the conditions mentioned in the order.
