ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993 **Shri Krishana Ambedkar Mahavidhalay Madhuban, Mau, Post- Madhuban, Tehsil - Madhuban, District- Mau - 221603, Uttar Pradesh** had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course of one year duration with an annual intake of 100 (one hundred only) students in terms of section 14(1) on NCTE Act 1993. on 31.10.2008.

AND WHEREAS, the matter was placed before NRC in its 141st meeting held on May 22-24, 2009 and the Committee decided to constitute the VT. Further, the land is to be registered in the name of the institute within 90 days. Accordingly, letter was issued to the institute on 30.04.2009.

AND WHEREAS, the inspection of the institution u/s 14 was conducted on 05.07.2009 and VTR was considered by the committee in its 146th meeting held on August 5 - 7, 2009 and the Committee decided to issue show cause notice to the institution and directed the institution to reply within 21 days. Accordingly show cause notice issued to the institution on 12.08.2009.

AND WHEREAS, reply of the institution (in response to show cause notice) was considered by the committee in its 151st meeting held on October 20-21, 2009 and the Committee decided that VT be sent again to verify the facts of removal of deficiencies.

AND WHEREAS, the re- inspection of the institution was conducted on 12.02.2010 and the inspection report was considered by the committee in its 159th meeting held from 28th April to 1st May, 2010, with original file of the institution ,VTR and other related document of the NCTE, Act 1993 the committee decided to issue show notice to the institute. Accordingly, the Show Cause Notice issued to the institute on 14.05.2010.

AND WHEREAS, the reply received from the institution (in response to show cause notice) was placed in its 162nd meeting held on June 24-27, 2010, the committee decided to issue letter under clause 7(9) of regulations 2007. Accordingly, L.O.I was issued to the institute on 26.08.2010.

AND WHEREAS the reply dated 25.12.2010 of the Institution was placed before NRC in its 178th Meeting held from February 8-10,2011 & Committee decided that the institution be given formal recognition order under section 7(11) of the NCTE Act, 1993, **with usual condition for the session 2011-12 with intake.**

NOW, THEREFORE, in exercise of the powers vested under Section **14(3)** (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Shri Krishana Ambedkar Mahavidhalay Madhuban, Mau, Post- Madhuban, Tehsil - Madhuban, District- Mau - 221603, Uttar Pradesh** for conducting **B.Ed Course** of Secondary (Level) of one year duration with an annual intake of 100 (One hundred Only) students from the academic session **2011-2012** under clause 7(11) of NCTE Regulations subject to the following conditions:

- I. The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session **2011-2012** failing which the recognition will be effective from the academic session **2012-2013**.
- II. Formal orders for recognition/permission will operate for **2011-2012** only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session **2012-2013**.
- III. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

- IV. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- V. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993
