ORDER

WHEREAS in terms of Section 15 of the NCTE Act, 1993, **Institute of Informatics and Management Sciences, Garh Road, Anuyogi Puram, Near L.L.R.M. Medical College, Meerut-250004, Uttar Pradesh** has submitted an application (apn03631) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **additional intake of B.Ed. course** of One-year duration with an annual intake of **100 (One Hundred Only) students**.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Institute of Informatics and Management Sciences, Garh Road, Anuyogi Puram, Near L.L.R.M. Medical College, Meerut-250004, Uttar Pradesh** for conducting **B.Ed. Course** of One year duration with an annual additional intake of 100 (One Hundred Only) (Existing 100 + Additional 100 = 200) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time..

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.



7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.



ORDER

Institute of Informatics & Management Sciences, Anuyogi Puram, Near Medical College, Garh Road, Meerut-250004 (U.P.) had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for an additional intake of 40 (Forty) seats in B.Ed. course of One year duration from the academic session 2002-2003 in terms of Section 14 (1) of the NCTE Act, 1993.

On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has constructed the building for conducting the course on the above mentioned land.
- (iii) The institution has created an Endowment Fund of Rs 5,00,000/- (Rupees Five Lacs Only) and a Reserve Fund of Rs. 4,00,000/- (Rupees Four Lacs Only).
- (iv) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Institute of Informatics & Management Sciences, Anuyogi Puram, Near Medical College, Garh Road, Meerut-250004 (U.P.) for an additional intake of 40 (Forty) seats (Total unit of 100 seats) in B.Ed. course of One year duration from the academic session 2002-2003 subject to fulfillment of the following before the commencement of the session:-

- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2003-2004.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall **within ONE MONTH** of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the staff be maintained, in the form of FDR in favour of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
- (f) **Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.**

Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

The institution shall submit to the Regional Committee a **Self-Appraisal Report** at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

If the institution **contravenes any of the above conditions** or any of the provisions of the NCTE Act, Rules, Regulations and/ or order made or issued thereunder, the Regional Committee **may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.**
