CONTINUATION ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Shri Guru Amardass College of Education, Plot No. 449(6-0), Khasra No. 449 (6-0), Khasra No. 449(6-0), Street No. NA, Village- Karami, P.O- Mathana, Tehsil- Thanesar, Town –Pipli, District- Kurukshetra, Haryana, Pincode- 136118 was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 students vide order F.NRC/NCTE/NRCAPP-3382/4250/3440/6458/233thMeeting /90658-666 dated 03.03.2015, as per NCTE Regulations, 2014.

2. AND WHEREAS, the matter was placed before NRC in its 418th meeting of NRC held on 23rd & 24th January 2024 and the Committee decided as under:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines, and Visiting Team Report issued from time to time were placed before the Northern Regional Committee. The NRC made the following observations:

- 1) Basic Infrastructure i.e. classrooms, ICT room, Multipurpose Hall looked as per NCTE norms.
- 2) Library facility is moderate including its sitting accommodation and to be improved.
- 3) No lift is there for the 1st floor, the ramp is steep and not user friendly.
- 4) The infrastructure and instruction facilities are available. The lift is not available for disabled students. Library facilities are moderate. The faculties are deployed.
- 5) The approved plan as produced is not prepared by an architect registered with "Council of Architecture", New Delhi.
- 6) The approval plan as produced doesn't have the requisite information like, 4 sides elevation, 2 sectional elevations, foundation detail, column footing detail, area statement, FAR/FSI achieved, schedule of openings etc.
- 7) Site plan is devoid of road layout, parking layout, landscaping layout, etc. 4.
- 8) A revenue map is not incorporated in the approval drawing.
- 9) No setback between the building and the boundary mentioned in the site plan.
- 10) Deviation in physical infrastructure is found. Not matching with the approved plan.
- 11) Internal deviations are seen.
- 12) There is no lift for the physical handicap.
- 13) The ramp as seen is not accessible due to its high gradient slope.

- 14) Most of the faculties as uploaded in the portal have resigned and new faculties have joined, (1 principal and 15 faculties)
- 15) No. of books 4002 and titles 1100 (Its less than the required norms)

In addition to above the institution is also directed to submit the following:

- 1) The institution is required to submit a certified copy of the registered land documents as the land document and mutation certificate was not accepted by the VT.
- 2) Break-up of built-up area mentioned in the building plan for the education programmes not accepted by VT Member 1) Room Nos are not mentioned in the drawing, to compare and cross check. 2) Uploaded drawings are not clearly visible and readable.
- 3) Non-Encumbrance certificate from the competent govt. authority also not produced to the VT. The institution is required to submit the same.
- 4) The institution is required to submit the latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- 5) The institution has not submitted details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- 6) The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- 7) The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014
- 8) The institution is required to submit a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution / society.

Accordingly, First Show Cause was issued on 06.02.2024 and the reply from the institution was received in NRC on 07.03.2024.

3. **AND WHEREAS**, the said reply was considered by the NRC in its 422nd (Part-2) meeting of NRC held on 6th and 07th June, 2024 and the Committee decided that Final Show Cause Notice be issued on certain grounds under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice, before withdrawal of recognition.

Accordingly, Final Show Cause was issued on 13.08.2024 and the reply from the institution was received in NRC on 01.10.2024.

4. **AND WHEREAS**, the said reply was considered by the NRC in its 435th meeting held on 03rd & 04th March, 2025 and the Committee decided as under: -

“The file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee noted the following: -

- *The recognition was granted to the institution for conducting B.Ed. course of two –year duration from the academic session 2015-2016 with an annual intake of 100 students i.e. two units of 50 students each vide order No. F.NRC/NCTE/NRCAPP-3382/4250/3440/6458/233th Meeting/90658-666 dated 03.04.2015.*
- *As per decision of NRC taken in its 422nd meeting, Final Show Cause Notice was issued to the institution on 13.08.2024.*
- *The Committee considered the reply dated 24.08.2024 submitted by the institution received in NRC on 01.10.2024 in reply to Final Show Cause Notice issued to it and observed that the reply of the institution is satisfactory.*

Hence, the Committee decided that no action is required to be taken, and the status quo of the institution be maintained as recognized for offering B.Ed. course with an annual intake of 100 students i.e. two units of 50 students each. Continuation Order may be issued accordingly.”

5. **NOW THEREFORE**, the Northern Regional Committee, NCTE decided that the institution namely Shri Guru Amardass College of Education, Plot No. 449(6-0), Khasra No. 449 (6-0), Khasra No. 449(6-0), Street No. NA, Village- Karami, P.O- Mathana, Tehsil- Thanesar, Town – Pipli, District- Kurukshetra, Haryana, Pincode- 136118 be allowed for continuing recognition for conducting B.Ed. programme of two-year duration with an annual intake of 100 students i.e. two basic units of 50 students each.
