 - The institution shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a (c) Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
 - That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the managements / (d) Contd. 2... institutions.

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

(g) The institution shall regularly update their website.

- (h) The institution intending to run the teacher training programme approved above in a rented premises are required to shift to their permanent building. They are required to submit report in compliance of the requirement of NCTE Regulations on the subject.
- of NCTE Regulation dt. 27.12.2005 which reads as "The institution concerned, after appointing the requisite faculty / staff, shall put the information on its official website and also formally inform the Regional Committee concerned. The Regional committee concerned shall then issue a formal unconditional recognition order."
- 5. If the institution contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17 (1) of the NCTE Act, 1993.
