    - The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be (i) operated along with an official of the Northern Regional Committee.
    - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time (ii) to time.
