CONTINUATION ORDER

WHEREAS, the recognition under section 14/15 (3)(a) of NCTE Act, 1993 was granted to the institution namely Poornagiri College of Education, Plot No. 114, Village- Zhankat, Post office/Tehsil/Taluka/Town/City- Khatima, District- Udham Singh Nagar- 262308, State-Uttarakhand for conducting B.Ed. courses of one year duration with an annual intake of 100 students vide Order No. NRC/NCTE/NRCAPP-42/193rd meeting/2012/20454-460 dated 10.05.2012 from the academic session 2012-2013.

- 2. AND WHEREAS, the revised recognition order was issued to the institution for conducting B.Ed. programme of two year duration with an annual intake of 100 students i.e two basic units of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/NRCAPP-42/2015/96292-297 dated 30.04.2015 with the condition of adherence of provisions of NCTE Regulations, 2014. The institution was directed to submit the compliance report with all necessary documents but the same was not submitted.
- 3. AND WHEREAS, the matter was placed before NRC in its 411th meeting held on 15th Sep., 2023 and the Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:


The revised recognition for B.Ed. course was issued to the institution on 30/04/2015. The institution has not submitted compliance of revised recognition order. The matter considered in NRC and the committee noted the following:

- The institution is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.

- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit certified copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building safety certificate from the Competent Government Authority.
- The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- Status of NAAC.

The NRC decided that First Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Show Cause Notice



- 4. AND WHEREAS, First Show Cause Notice was issued to the institution on 29.09.2023 and the reply was submitted by institution on 30.12.2023.
- **5. AND WHEREAS,** the matter was placed before NRC in its 431st Meeting of NRC held on 09th to 11th Dec, 2024, and the Committee decided as under: -

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution namely Poornagiri College of Education, Plot No. 114, Village- Zhankat, Post office/Tehsil/Taluka/Town/City- Khatima, District-Udham Singh Nagar- 262308, State- Uttarakhand for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2012-2013 vide order dated 10/05/2012 and revised recognition order was issued to the institution for B.Ed. course of two-year duration with an annual intake of 100 seats (two units) vide order dated 30/04/2015.
- In compliance of Revised Recognition order, First Show Cause Notice was issued to the institution on 29/09/2023. The institution has submitted reply of SCN vide letter dated 30/12/2023.
- The reply submitted by the institution against the first show cause notice dated 29.09.2023 has been considered by the NRC and the same has been found satisfactory.

Hence, the Committee decided to issue Continuation Order for B.Ed. course of two years duration with an annual intake of 100 students (two units each of 50)."

- 6. NOW THEREFORE, in terms of the above decision of NRC, the institution namely Poornagiri College of Education, Plot No. 114, Village- Zhankat, Post office/Tehsil/Taluka/Town/City- Khatima, District- Udham Singh Nagar- 262308, State-Uttarakhand is hereby permitted for continuation of recognition for conducting B.Ed. Course for two-year duration with an annual intake of 100 students i.e two basic units of 50 students each.
- 8. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
