RESTORATION ORDER

WHEREAS, the recognition was granted to the institution namely Dr. Sushila Tiwari B.Ed. College of Education, Khasra No.-288/1, 335, 335 B, Khatima Road, Old Menka Theatre, Sitarganj, District-Udham Singh Nagar, State-Uttarakhand for B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2006-2007 vide order No. F.NRC/NCTE/F-3/UR-38/3073-3082 dated 25.07.2006.

- AND WHEREAS, the revised recognition was granted to the institution for conducting B.Ed. programme of two year duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. F.No./NRC/NCTE/UR-38/2015/114334-339 dated 06.06.2015 with the condition of adherence of provisions of NCTE Regulations, 2014. The institution had not submitted compliance of Revised Recognition Order.
- AND WHEREAS, the matter was placed before NRC in its 407th Meeting held on 10th August, 2023 and the Committee decided that Final Show Cause Notice under section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Final Show Cause Notice.
- AND WHEREAS, final Show Cause Notice u/s17 was issued to the institution vide letter No. 4. F.No.NRC/NCTE/UR-38/B.Ed./407th Meeting 2023/223138 dated 24.08.2023.
- AND WHEREAS, the institution had submitted reply vide its letter dated 31.10.2023 in response 5. to final show cause notice. The matter was considered by NRC in its 418th Meeting held on 23rd and 24th January 2024 and the Committee decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the NRC after careful consideration made the following observations: -


- The building plan submitted by the institution is neither approved nor is legible. Further earmarked build up area course wise is not mentioned the building plan.
- Vide letter dated 12.10.2023, 14 faculty have been approved by the University whereas proforma of only 11 faculty signed by the Registrar Kumaun University has been submitted The institution is required to submit again with bank Statements of all 16 faculty. It is also pertinent to mention that the date of approval has not been mentioned by the Registrar of the University over the Registrar of the proforma.

Administrative and professional staff have not been appointed as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014.

• The institution has not submitted the additional information as per Clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations dated 28.04.2017.

Hence therecognition granted to Dr. Sushila Tiwari B.Ed. College of Education, Khasra No.-288/1, 335, 335 B, Khatima Road, Old Menka Theatre, Sitarganj, District-Udham Singh Nagar, State-Uttaranchal for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted from now onwards. However, if any student is pursuing B.Ed. programme is allowed to continue till, they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

- **6. AND WHEREAS**, withdrawal Order was issued to the institution vide order No. F.No. NRC/NCTE/UR-38/B.Ed./418th Meeting/2024/224412-418 dated 06.02.2024.
- 7. **AND WHEREAS**, the institution filed an appeal before appellate authority in u/s18 of NCTE Act 1993, against Withdrawal Order dated 06.02.2024 of NRC and the Appellate Authority remanded the case back to the NRC.
- **8. AND WHEREAS**, the matter was considered by NRC in its 425th Meeting held on 27th August, 2024 and the Committee decided as under:

"The original file of the institution alongwith Appeal Order, other related documents, NCTE Act, 1993 Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee."

• The Committee noted that the withdrawal order 06.02.2024 has already been set aside by the Appellate Authority vide its Order dated 22.08.2024 and the case has been remarded back to NRC for consideration, therefore, NRC decided that the recognition granted to the institution for running B.Ed. (two units) programme is restored until a fresh withdrawal order is issued by NRC.


Order be issued accordingly.

The Committee further deliberated the case and decided that the faculty list submitted by the institution before the Appellate Authority during hearing of its appeal be verified from the Affiliating University and the reply received be placed before NRC for further action.

Action be taken accordingly."

9. NOW THEREFORE, in terms of above decision of NRC, the recognition granted to the institution viz to Dr. Sushila Tiwari B.Ed. College of Education, Khasra No.-288/1, 335, 335 B. Khatima Road, Old Menka Theatre, Sitarganj. District-Udham Singh Nagar, State-Uttarakhand is hereby restored for B.Ed course for two basic units of 50 students each.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
