
The case of the institution was considered by the NRC in its 317th (Virtual) Meeting held on 22nd to 23th September, 2020 and the Committee decided as under:-

As per Letter /Memo No. KW 12/16-2003 C-II (3) dated 10.09.2018 issued by Principal Secretary to Govt. of Haryana, Higher Education Department, Chandigarh/Panchkula and subsequent Memo No. KW 12/16-2003 C-II (3) dated 21.01.2020 no application for opening of B.A.B.Ed./B.Sc.B.Ed. (4 year Integrated) and B.Ed. courses/B.Ed. colleges can be entertained for the academic session 2018-2019-2020 and 2020-2021-22 respectively.

The Committee carefully examined the matter and is of the opinion that the detailed scrutiny of application of the institution is required. The implementation of the recognition order being stayed for the academic session 2020-21. The institution is directed not to admit students for the academic session 2020-2021 till conclusion of the scrutiny of the file. and decision of NRC

Hence, a letter to that effect be issued to the institution accordingly as well as to the Affiliating University and Principal Secretary Higher Education Department, Govt. of Haryana.


