ORDER

**Doon Valley Institute of Education, Outside Jundla Gate, Karnal - 132001, Haryana** submitted an application to the Northern Regional Committee of National Council for Teacher Education for permission of two additional unit in its existing B.Ed. Course in terms of section 15(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Doon Valley Institute of Education** to conduct **B.Ed. Course** of One year duration **w.e.f. the session 2006-2007** with an annual intake of **300 (Three Hundred) (100+200)** students, subject to appointment of staff as per NCTE Regulations and ratification by the University, at the following address :-

**Doon Valley Institute of Education,  
Outside Jundla Gate,  
Karnal - 132001,  
Haryana.**

3. The institution shall ensure the fulfillment of the following :-

- The institution shall maintain the teaching staff strength of 1+21 for the B.Ed. Course.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- The institution shall regularly update its website.
