ORDER FOR WITHDRAWAL OF RECOGNITION.

WHEREAS, the Recognition was granted to the institution namely Shri Sai College of Education, Kohla, Nadaun, Dist- Hamirpur, Himachal Pradesh for D.El.Ed course of two years duration with an annual intake of 50 students vide order No. F.NRC/ NCTE/ HP-216/2008/67282 dated 23.12.2008.

2. AND WHEREAS, as per the directions of the Hon'ble High Court of Himachal Pradesh at Shimla in W.P. No. 1311 dated 12.12.2018, the inspection of the institution u/s 13 of the NCTE Act was conducted by NCTE. The Visiting Team Report and other documents were considered by NRC in its 397<sup>th</sup> Meeting held on 18<sup>th</sup>-19<sup>th</sup> April 2023 and the Committee noted that the institution submitted a letter dated 10<sup>th</sup> October 2021 to the Visiting Team Members requesting to withdraw the recognition granted for the D.El.Ed course.

3. AND WHEREAS, the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee **decided to accede to the request of the institution and withdraw the recognition granted to the institution for D.El.Ed course.**

4. NOW THEREFORE, in view of the above decision of NRC, the NRC hereby **withdraws** recognition granted to Shri Sai College of Education, Kohla, Nadaun, Dist- Hamirpur, Himachal Pradesh for D.El.Ed course of two years duration granted vide order No. F.NRC/NCTE/HP-216/2008/67282 dated 23.12.2008.

5. Further, if the institution is not satisfied with the order, it may prefer an Appeal under section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
