RESTORATION OF RECOGNITION ORDER

WHEREAS, the institution namely Tau Devi Lal Memorial College of Education, Plot No.- 7558, Street No. – Manana Road, Village – Manana, Post Office – Samalkha, Tehsil/Faluka – Samalkha, Town/City – Samalkha, District – Panipat – 132 101, Haryana was granted recognition for conduct of B.A.B.Ed. programme with an annual intake of two units (50 students each) from the academic session 2020-2021 vide NRC order No.F.No.NRC/NCTE/NRCAPP14194/301st Meeting/2019/203458-63 dated 27.05.2019.

2. WHEREAS, the institution approached the Hon'ble Supreme Court of India in Writ Petition No.726/2019 for change of academic session from 2020-2021 to 2019-20. The Hon'ble Supreme Court passed an order dated 14.06.2019 as under:-

1. In view of the order passed by this Court on 11.06.2019 in writ petition © No.541 of 2019, the instant writ petition stand disposed of in the same terms.


3. WHEREAS, the matter was considered by NRC in its 302nd Emergent Meeting held on 20th to 21st June, 2019. The Committee decided as under:

- If the academic session is changed-as on today, it will invite further rounds of litigation for the NCTE, the State affiliating bodies.
- The State Representative of Haryana in Northern Regional Committee, Dr. Sunil Bajaj, who was present in 302nd Emergent Meeting brought to the notice of the Committee that the time schedule fixed by the Hon'ble Supreme Court should be adhered to stating and all the affiliating Universities in the State of Haryana are bound by the said judgement and violation may result in disrespecting the court order and setting wrong precedence.
- Further, the recognition to any institution / course is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating university/body, State Govt. etc.

Hence, in order to avoid further litigation / contravention, NRC, NCTE decided not to change the academic session of recognition from the year 2020-21 to 2019-20.

4. WHEREAS, the institution was informed accordingly vide NRC order no.F.No.NRC/NCTE/NRCAPP14194/302nd Meeting/2019/205018-21 dated 24.07.2019.

5. WHEREAS, the matter was again placed before the NRC in its 317th meeting held on 22nd to 23rd September 2020. The NRC in its 317th meeting decided as under:

- As per Letter /Memo No. KW 12/16-2003 C-II (3) dated 10.09.2018 issued by Principal Secretary to Govt. of Haryana, Higher Education Department, Chandigarh/Panchkula and subsequent Memo No. KW 12/16-2003 C-II (3) dated 21.01.2020 no application for opening of B.A.B.Ed./B.Sc.B.Ed. (4 year Integrated) and B.Ed. courses/B.Ed. colleges can be entertained for the academic session 2018-2019-2020 and 2020-2021-22 respectively.
- The Committee carefully examined the matter and is of the opinion that the detailed scrutiny of application of the institution is required. The implementation of the recognition order being stayed for the academic session 2020-21. The institution is directed not to admit students for the academic session 2020-2021 till conclusion of the scrutiny of the file. and decision of NRC

Hence, a letter to that effect be issued to the institution accordingly as well as to the Affiliating University and Principal Secretary Higher Education Department, Govt. of Haryana.

6. WHEREAS, the institution and the concerned departments were informed accordingly vide NRC order no.F.No.NRC/NCTE/NRCAPP-14194/317th (Virtual Meeting/2020/209757-60 dated 29.09.2020.

7. WHEREAS, the institution filed a writ W.P. (C) 7514/2020 & CM. No. 25030/2020 (for stay) & 25031/2020 (for Direction) before the Hon'ble High Court of Delhi against the decision of NRC which was communicated to the institution vide letter dated 29.09.2020 and Hon'ble High Court has stay the impugned order dated 29.09.2020 of NRC vide their order dated 06.10.2020

8. WHEREAS, the matter was placed before the NRC in its 321st meeting held on 18th November 2020. The NRC in its 321st meeting made the following observation:

- a) NRC has issued recognition Order No. NRC/NCTE/NRCAPP-14194/301st Meeting/2019/203458-63 dated 27.05.2019 for BA.B.Ed./B.Sc.B.Ed. course for two units.
- b) In view of Letter/Memo No. KW 12/16-2003 C-II (3) dated 10.09.2018 issued from Principal Secretary to Govt. of Haryana, Higher Education Department, Chandigarh/Panchkula and subsequent Memo No. KW 12/16-2003 C-II (3) dated 21.01.2020, wherein ban on B.A.B.Ed./B.Sc.B.Ed. (4 year Integrated) and B.Ed. courses/B.Ed. colleges from the academic session 2018-2019-2020 and 2020-2021-2022 respectively.
- c) NRC reviewed the decision on Recognition Order No. NRC/NCTE/NRCAPP-14194/301st Meeting/2019/203458-63 dated 27.05.2019 for B.A.B.Ed./B.Sc.B.Ed. (4 year Integrated) course with annual intake of 2 basic units (100 students) has decided to stands cancelled henceforth vide NRC's order No. NRC/NCTE/NRCAPP-14194/317th (Virtual) Meeting/2020/209757-60 dated 29.09.2020.
- d) The institution has filed W.P. (C) 7514/2020 & CM. No. 25030/2020 (for stay) & 25031/2020 (for Direction) before the Hon'ble High Court of Delhi against the decision of NRC which was communicated to the institution vide letter dated 29.09.2020 and Hon'ble High Court has stay the impugned order dated 29.09.2020 of NRC vide their order dated 06.10.2020

Hence NRC confirms its decision already conveyed to RD for filling appeal against the stay order of Hon'ble High Court of Delhi dated 06.10.2020, to save the future of the students.

9. **WHEREAS**, the NRC in its 338th meeting held on 27th, 28th & 29th July, 2021 reviewed its decision taken in 321st meeting and decided as under:

- The Committee reviewed the matter and decided that the above decision taken by NRC in its 321st meeting held on 18th November, 2020 may be treated as withdrawn with immediate effect.

10. **WHEREAS**, the above decision of the NRC was informed to the institution accordingly vide NRC letter No.F.No.NRC/NCTE/NRCAPP-14194-B.A.B.Ed./B.Sc.B.Ed./2021/216035-6037 dated 29.10.2021

11. **WHEREAS**, the institution filed a writ petition W.P.(C) No.7514/2020 &CM APPLs. 25030/2020, 25031/2020 before the Hon'ble High Court of Delhi against the order dated 03.09.2020. The Hon'ble High Court of Delhi passed an order dated 04.05.2023 i.r.t. W.P.(C) 7514/2020 & CM APPLs. 25030/2020, 25031/2020 as follows:

- The respondent no.2 shall issue consequential information to all concerned, intimating them that the earlier order of cancellation of recognition has been withdrawn and the petitioners-institution stood recognized. Let the name of the petitioner-institution be also reflected as recognized institutions in the official web portal of the respondent No.2, if any maintained.
- Let the fresh restoration order of recognition be also issued by the respondents.

12. **WHEREAS**, the matter was placed before the NRC in its 399th meeting held on 26th May 2023. The NRC in its 399th carefully considered the matter in light of Court order dated 04/05/2023 passed in W.P. (C) 7514 /2020 and the NRC noted the following:

- The recognition granted to the institution was cancelled by NRC vide order dated 03/09/2020. The institution challenged the cancellation before the Hon'ble High Court of Delhi in the W.P. (C) 7514/2020 clubbed with W.P. (C) 6396/2020.
- The Hon'ble Court vide order dated 14/09/2020 stayed the operation of order dated 03/09/2020 of the NRC.
- The matter was considered by NRC in its 338th meeting held on 27th to 29th July 2021 and further decided that earlier decision for cancellation of recognition be reviewed. Accordingly the order dated 3/9/2020 was treated to be withdrawn with immediate effect.

In view of the above facts and the Hon'ble Court order dated 04/05/2023 the NRC decided the following:

- The fresh restoration order be issued to the institution.
- The name of the institution be reflected as recognized institution on the website of the NCTE.
- The affiliating University/ State Govt may accordingly be intimated.

NOW, THEREFORE, the Northern Regional Committee hereby *restore* recognition/permission granted to the institution viz. **Tau Devi Lal Memorial College of Education, Plot No.- 7558, Street No. – Manana Road, Village – Manana, Post Office – Samalkha, Tehsil/Taluka – Samalkha, Town/City – Samalkha, District – Panipat – 132 101, Haryana for conduct of B.A.B.Ed. programme with an annual intake of 100 (02 units) (50 students each) from the academic session 2020-2021 vide NRC order No. No.F.No.NRC/NCTE/NRCAPP14194/301st Meeting/2019/203458-63 dated 27.05.2019.**

The institution shall adhere to the fulfillment of the provisions of the NCTE Regulation, 2014 as amended from time to time and ensure the following before commencement of the session:-

- i. The institution shall comply with various other norms and standards prescribed in the NCTE Regulations as amended from time to time.
 - ii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms and Procedure) Regulations, 2014.
 - iii. The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulation, 2014 as amended vide Notification on 29.04.2017
 - iv. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
 - v. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
13. Further the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, Affiliating University / Body, the State Government etc., as applicable.
14. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
15. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time.
16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

17. If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made of issued there under, the action including withdrawal of recognition shall be taken by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.1993.

18. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act., 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's Website.
