WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution viz GTB College, Plot No. 557mim (6-0), Street No.- Balloh Roa, Village- Balloh, P.O.- Joga, Tehsil/Taluka- Phool, Town/City- Phool, District- Bathinda, State- Punjab- 148109 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two units) from the academic session 2015-2016 vide NRC order No. NRC/NCTE/NRCAPP-4578/5791/7706/8764/4257/4261/5631/5468/3890/5484/7392/3425/ 5201/6845/4290/233rd Meeting/89849-868 dated 03.03.2015.

2. AND WHEREAS, the matter was placed before NRC in its 410th Meeting held on 04th & 05th September, 2023 and the Committee decided as under: -

The Order dated 29.08.2023 passed by the Hon'ble High Court of Punjab and Haryana at Chandigarh in CWP No. 17369/2023 titled as Syon College of Education & Welfare Society vs. State of Punjab and Anr. was perused by the NRC. The operative part is as under: -

"in the States of Punjab and Haryana all the recognitions granted by the NCTE appears to be conditional, granted in derogation of a direction issued by the Supreme Court in the case titled as "Adarsh Shiksha Mahavidyalaya vs. Subhash Rehangdale and others", (2012) 2 Supreme Court Cases 425 and that there is non-compliance of the direction by the Regional Committee of NCTE the Director of the Regional Committee be remain present in the Court on the next date of hearing."

The NRC after perusal of directions of Hon'ble Court decided as under: -

The NRC decided that the to recommend NCTE Hqrs. to conduct the inspection of following 15 TEIs on u/s 13 of NCTE Act, 1993 and provide the report to NRC.

3. AND WHEREAS, the matter was placed before NRC in its 413th Meeting (Virtual) held on 29th September, 2023 and the Committee decided as under: -

"The original file of the institution along with the report of Visiting Team dated 25.09.2023 conducted U/S 13 of NCTE Act, 1993 and other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

- College has not participated in the inspection thus the documents uploaded in the report section could not be verified by the VT Members.

The NRC decided that First Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Show Cause Notice on the following grounds:

The institution is required to explain the reason of not participating in the virtual inspection conducted by the NCTE”

4. **AND WHEREAS**, the First Show Cause Notice U/S17 was issued to the institution on 30.09.2023.

5. **AND WHEREAS**, the institution has submitted reply of Show Cause Notice U/S17 vide letter dated 16.10.2023 and received in NRC office on 27.10.2023.

6. **AND WHEREAS**, the matter was placed before the NRC in its 418th Meeting held on 23rd and 24th January, 2024 and the committee decided as under: -

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines, and Visiting Team Report issued from time to time were placed before the Northern Regional Committee. The NRC made the following observations: -

1. *The inspection of the institution was not done on the date scheduled for inspection.*
2. *First SCN was issued to the institution on 30.09.2023 the institution replied that inspection could not be conducted as they got the information belatedly from NCTE.*

*The NRC **decided** the following: -*

*The institution is hereby given the last opportunity through **Final Show Cause Notice** before withdrawal of recognition u/s 17 of NCTE Act for conducting inspection of the institution on submission of inspection fee of Rs. 1.5 lakh + 18% GST through the Demand Draft in favour of Member Secretary, NCTE payable at New Delhi within a period of 7 days from the date of issue of the letter.*

Accordingly, final show cause notice issued on 06.02.2024 and reply dated 21.02.2024 from the institution received in NRC on 28.02.2024.

7. **AND WHEREAS**, the matter was placed before the NRC in its 422nd Meeting held on 06th & 7th June, 2024 and the Committee decided as under: -

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

In response to Final Show Cause Notice dated 06.02.2024, the reply submitted by the institution vide letter dated 28.02.2024 was considered by the NRC and the Committee observed the following:

- The institution has not deposited the Inspection fee of Rs. 1.5 Lakh + 18% GST rather it has requested to waive of the inspection fee and provide an economical relief to the institution.

Hence, the Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the date of communication of withdrawal order. Hence, no fresh admission shall be done in next academic session i.e. 2024-25."

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby **Withdraw Recognition** of **GTB College, Plot No. 557mim (6-0), Street No.- Balloh Roa, Village- Balloh, P.O.- Joga, Tehsil/Taluka- Phool, Town/City- Phool, District- Bathinda, State- Punjab- 148109** for conducting B.Ed programme with annual intake of 100 students(02 basic unit) with effect from the date of communication of withdrawal order.

No fresh admission shall be done in next academic session i.e. 2024-2025.

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.


