CLOSURE/ WITHDRAWAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Gurukul College of Education, Plot/Khasara No.- 88/1/1/(0-14) 1/2(7-6), Street No.- Rampura, Village- Lehra Bega, Post Office- Lehra Bega, Tehsil/Taluka- Bathinda, Town/City- Bhuchio Mandi, District- Bathinda, Punjab- 151101 was granted recognition for conducting B.Ed. programme of two year duration with an annual intake 100 seats (two basic units) vide recognition Order No. NRC/NCTE/NRCAPP-4578/5791/7706/8764/4257/4261/5631/5468/3890/5484/7392/3425/5201/6845/4290/233rd Meeting/89849-868 dated 03.03.20215 from the academic session 2015-2016, as per NCTE Regulations, 2014.

2. AND WHEREAS, the matter was placed before NRC in its 410th Meeting held on 04th & 05th September, 2023 and the Committee decided as under: -

"The Order dated 29.08.2023 passed by the Hon'ble High Court of Punjab and Haryana at Chandigarh in CWP No. 17369/2023 titled as Syon College of Education & Welfare Society vs. State of Punjab and Anr. was perused by the NRC. The operative part is as under: -

"in the States of Punjab and Haryana all the recognitions granted by the NCTE appears to be conditional, granted in derogation of a direction issued by the Supreme Court in the case titled as "Adarsh Shiksha Mahavidyalaya vs. Subhash Rehangdale and others", (2012) 2 Supreme Court Cases 425 and that there is non-compliance of the direction by the Regional Committee of NCTE the Director of the Regional Committee be remain present in the Court on the next date of hearing."

The NRC after perusal of directions of Hon'ble Court decided as under: -

The NRC decided that the to recommend NCTE Hqrs. to conduct the inspection of following 15 TEIs on u/s 13 of NCTE Act, 1993 and provide the report to NRC.

3. AND WHEREAS, the inspection under section 13 of NCTE Act, 1993 was constituted to the institution on 22.09.2023 and VTR Uploaded by VT Members 22.09.2023. The VT Report of the institution is being screen shared before NRC.

4. AND WHEREAS, the matter was placed before NRC in its 412th Meeting held on 25th September, 2023 and the Committee decided as under: -

"The original file of the institution along with the report of Visiting Team dated 22.09.2023 conducted u/s 13 of NCTE Act, 1993 and other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

- The institute has mentioned that they get approval of NCTE in 2015, but due to some problem they couldn't received approval from affiliating University.
- The institute has not yet admitted any student in education program so far. Institute is also not willing to start the education program (UG or PG) now and not willing for the inspection to be carried out.
- The institution is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit certified copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building safety certificate from the Competent Government Authority.
- The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- The institution is required to submit affiliating letter for B.Ed. course issued by the affiliating body.

The NRC decided that First Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Show Cause Notice."

Accordingly, show cause notice issued on 29.09.2023.

5. **AND WHEREAS**, the Society viz. *Swami Dayanand Educational Society @ Bhucho Mandi (Bathinda) Punjab* has submitted its reply vide letter dated 11.10.2023 of First Show Cause Notice u/s 17 received in NRC on 17.10.2023 requesting the following: -

On behalf of Swami Dayanand Educational Society (R) Bhucho Mandi (Bathinda) Punjab I humbly submit that the society is not willing to start under the name and style of Gurukul College of Education, Village -Lehra Bega, Bhucho Mandi (Bathinda) Punjab for Bachelor of Education (B.Ed.) course with annual intake of 100 seats. You are humbly requested to withdraw the recognition granted to Swami Dayanand Educational Society (R) Bhucho Mandi (Bathinda) Punjab to start Gurukul College of Education, Village - Lehra Bega, Bhacho Mandi (Bathinda) Punjab for Bachelor of Education (B.Ed.) course with annual intake of 100 seats. You are humbly requested to do the needful and oblige."

6. **AND WHEREAS**, the matter placed before ERC in its Minutes of 422nd (Part-2) Meeting of NRC held on 06th and 07th June, 2024 and The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

- *The Committee considered the representation submitted by the institution requesting to close the institution for running B.Ed. course and the Committee decided to agree to close the institution as requested by the institution by withdrawing the recognition granted to Gurukul College of Education, Plot No. - 88/1/1(0-14) 1/2(7-6), S.No. - Rampura, Village - Lahra Bega, Tehsil/Taluka - Bathinda, Town/City - Bhucho Mandi, Distt. - Bathinda, PB - 151101 for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 with immediate effect.*

Order be issued accordingly and the FDRs may also be returned.

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to **Gurukul College of Education, Plot/Khasara No.- 88/1/1(0-14) 1/2(7-6), Street No.- Rampura, Village- Lehra Bega, Post Office- Lehra Bega, Tehsil/Taluka- Bathinda, Town/City- Bhucho Mandi, District- Bathinda, Punjab- 151101** for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 seats (two basic units).

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act, 1993:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or

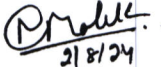

University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.

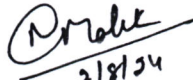
