#### **ORDER**

- 1. WHEREAS, the recognition was granted to the institution namely The Asian School for Teachers Education, Vasant Vihar, (Indira Nagar) Dehradun -248006 for B.Ed. course of one year duration with an annual intake of 100 Students vide order No. F.NRC/NCTE/F-3/UR-56/8565-8574 dated 12.05.2005.
- 2. AND WHEREAS, the matter was considered by NRC in its 405<sup>th</sup> Meeting held on 24 July, 2023 and the Committee decided as under:-

"The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed the following:

- After promulgation of NCTE Regulations, 2014, the institution has not consented to come under the Regulations 2014 and affidavit in this regard was also not submitted by the institution. Hence, revised recognition order for B.P.Ed. two year duration was not to the institution.
- The institution is required to submit proof / evidence to prove that it is a Multi disciplinary institution as per clause 2(b) Regulations, 2014. of NCTE
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land purpose.
- The institution is required to submit Non-Encumbrance Certificate issued Competent by the Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building safety certificate from the Competent Government Authority.
- The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from Competent Authority.
- The institution is required to submit Building Completion Certificate Competent Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by
  concerned affiliating body in original with the details of their teaching subject, date of birth, date
  of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE'S

GOI dated 09.06.2017), salary structure and related documents duly attested by documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.

- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.

Hence, the NRC decided that First Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Show Cause Notice."

- 3. AND WHEREAS, accordingly, First Show Cause Notice was issued to the institution on 10.08.2023 and reply not submitted by the institution.
- **4. AND WHEREAS**, the matter was considered by NRC in its 417<sup>th</sup> Meeting held on 04<sup>th</sup> January, 2024 and the Committee decided as under:-

"The matter placed before NRC in its  $417^{th}$ Meeting held on  $04^{th}$  January, 2024 and the Committee decided that final show cause under Section 17 of NCTE Act, 1993 be issued to the institutions to submit reply within 07 days from the date of issue of final show cause notice on the above grounds"

- 5. AND WHEREAS, accordingly, Final Show Cause Notice was issued to the institution on 08.02.2024 on the above grounds.
- 6. AND WHEREAS, point wise reply not submitted by the institution. The institution vide letter dated 19.02.2024 has informed that the institution had started the B.Ed. College in the academic session 2005-2006. Since no classes were conducted after the Academic session 2006-2007, we close the college.
  - 1. "The institution enclosed a letter vide letter dated 14.12.2007 has informed to the DIET, Raipur, Dehradun is as" हम आपको अवगत करना चाहते है की पिछले सत्र (2006-2007) की भांति हमने सन 2007 -2008 में बी.एड. न चलाने का फैसला किया है " and the Society vide letter dated 16.03.2009 also informed to Mr. Indudhar Bodai, Assistant Secretary, Uttarakhand Government, Dehradun that the Asian School for Teachers Education is not running now."
- 7. AND WHEREAS, the matter was considered by NRC in its 423<sup>rd</sup> Meeting held on 15<sup>th</sup> July, 2024 and the Committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.

- The Committee considered the representation submitted by the institution requesting to close the institution for running B.Ed. course and the Committee decided to allow the closure application and agreed to close the institution as requested by the institution by withdrawing the recognition granted to The Asian School for Teachers Education, Vasant Vihar, (Indira Nagar) Dehradun 248006 for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 with immediate effect. FDRs be also returned.
- The Website of NRC may also be updated accordingly.

Order be issued accordingly."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17 of NCTE Act, 1993, the Northern Regional Committee is hereby withdraw the recognition granted to The Asian School for Teachers Education, Vasant Vihar, (Indira Nagar) Dehradun -248006 for conducting B.Ed. course of two years duration with an annual intake of 100 students under clause 17(1) of NCTE Act, 1993 with immediate effect.
- 9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website. <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
